US Businesses need clear line of sight to revenue, product growth, cost savings and reduced risks.






Expanding BPS through Licensing

By-Product Synergy is the matching of under-valued waste, transportation, energy and other streams from one facility with potential users at another facility to create new revenues or savings, environmental and societal benefits.



By-Product Synergy Process












Ecological Life Cycle Assessment

Eco-LCA is a framework to account for the role of ecosystems in supporting human activities



Considers ecosystem services in physical units Provides many footprints – Carbon, Water, Nitrogen



Based on Year-One Results Estimated Resource Savings

- \$4.2 million in waste disposal costs and virgin material savings
- 250 million gallons of water
- 6 million barrels of oil-equivalent energy
- 3,000 acres of land
- 13,000 metric tons of carbon dioxide equivalent
- 29,000 metric tons of non-renewable resources







Commercial and Industrial Property Assessed Clean Energy Financing

HOW IT WORKS













Companies identify cost effective retrofits and request funding from City or County

City or County creates special tax district allowing property owners to receive financing for Energy Efficiency and Renewable Energy Barclays funds all projects through city or county special tax district with 100% private capital

PACE BENEFITS

- Jobs creation -- 5 million jobs nationally
- Economic Stimulus -- \$500 billion through the construction trades, with strong local multiplier
- Infrastructure development -- large scale upgrade to the nation's power grid privately financed
- ✓ GHG reduction -- large carbon footprint reduction done profitably


