

Safe disposal of medical syringes

Sharps container exchange program



What are sharps?

Sharps are medical instruments such as needles, IV tubing with needles, scalpel blades, lancets, glass tubes and syringes that can cause injury, spread infection or pollute the environment when used or disposed of improperly.

Why is safe disposal important?

Sharps can harm people, pets and wildlife when discarded improperly. Placing hypodermic needles and other sharps in the trash, for example, exposes garbage haulers and other disposal workers to potential injury. Because of this and other public safety concerns, it's illegal in Oregon to dispose of syringes and other medical sharps in the garbage. The law also requires that medical sharps be disposed of in approved sharps containers.

What is an approved sharps container?

Oregon law requires that regulated medical waste be stored and disposed of in rigid, leakproof, puncture-resistant containers clearly marked with the biohazard symbol and sealed for safety. They're available at many local pharmacies, medical supply stores and Metro's two household hazardous waste facilities. See the back of this brochure for Metro's facility addresses. For worker safety, customers who bring sharps in containers that Metro cannot accept will be asked to transfer them to an approved container.

How can I dispose of sharps safely?

The Portland metropolitan area offers various options for safe sharps disposal. Some pharmacies and garbage haulers provide sharps containers and disposal service for a fee. Find several resources listed on the back of this brochure, or call Metro's recycling hotline at 503-234-3000 for more information.

Metro also provides an affordable container exchange program for area residents, who can take their sharps containers to the household hazardous waste facility at Metro Central Station in Northwest Portland or Metro South Station in Oregon City between 9 a.m. and 4 p.m. Monday through Saturday. The program helps protect workers from the risk of needle injuries and helps maintain safe, livable neighborhoods.

Who can participate in Metro's container exchange program?

Metro's program is only for residents and households, not businesses. Group homes, residential care facilities and other commercial or business customers should contact a medical waste management company, their garbage hauler or Metro's recycling hotline at 503-234-3000 for sharps disposal options.

How does Metro's container exchange program work?

- 1 Enroll at one of Metro's household hazardous waste facilities for just \$5 per container, and get a new sharps container at no cost each time you submit a full one for proper disposal.
- 2 Bring your sharps container to one of Metro's hazardous waste facilities – see the addresses on the back of this brochure – for proper disposal. A hazardous waste disposal fee of \$5 for up to 35 gallons also applies.

- 3 Receive a new empty container.
