<b>2.0</b>	<b>CONDITIONS AND DISCLAIMERS</b>	
<b>2.1</b>	<b>Guarantees</b>	This license shall not vest any right or privilege in the Licensee to receive specific quantities of solid waste at the direction of Metro during the term of the license.
<b>2.2</b>	<b>Non-exclusive license</b>	This license shall not in any way limit Metro from granting other solid waste licenses within Metro's boundaries.
<b>2.3</b>	<b>Property rights</b>	This license does not convey any property rights in either real or personal property.
<b>2.4</b>	<b>No recourse</b>	The Licensee shall have no recourse whatsoever against Metro or its officials, agents or employees for any loss, costs, expense or damage arising out of any provision or requirement of this license or because of the enforcement of the license or in the event Metro determines that the license or any part thereof is invalid.
<b>2.5</b>	<b>Indemnity</b>	The Licensee shall indemnify Metro, the Council, the Chief Operating Officer ("COO"), and any of their employees, or agents and save them harmless from any and all loss, damage, claim, expenses including attorney fees, or liability related to or arising out of the granting of this license or the Licensee's performance of or failure to perform any of the obligations under the license or Metro Code Chapter 5.01, including without limitation patent infringement and any claims or disputes involving subcontractors.
<b>2.6</b>	<b>Binding nature</b>	This license is binding on the Licensee. The Licensee is liable for all acts and omissions of the Licensee's contractors and agents.
<b>2.7</b>	<b>Waivers</b>	To be effective, a waiver of any terms or conditions of this license must be in writing and signed by the COO.
<b>2.8</b>	<b>Effect of waiver</b>	Waiver of a term or condition of this license shall not waive nor prejudice Metro's right otherwise to require subsequent performance of the same term or condition or any other term or condition.
<b>2.9</b>	<b>Choice of law</b>	The license shall be construed, applied, and enforced in accordance with the laws of the State of Oregon.
<b>2.10</b>	<b>Enforceability</b>	If a court of competent jurisdiction determines that any provision of this license is invalid, illegal or unenforceable in any respect, the validity of the remaining provisions contained in this license shall not be affected.



<b>2.11</b>	<b>License not a waiver</b>	This license does not relieve any owner, operator, or the Licensee from the obligation to obtain all required permits, licenses, or other clearances and to comply with all orders, laws, regulations, reports or other requirements of other regulatory agencies.
<b>2.12</b>	<b>License not limiting</b>	This license does not limit the power of a federal, state, or local agency to enforce any provision of law relating to the facility.
<b>2.13</b>	<b>Definitions</b>	<ol style="list-style-type: none"> <li>1. Unless otherwise specified, all other terms are as defined in Metro Code Chapter 5.00.</li> <li>2. "Mixed Non-Putrescible Waste" means a mixture of more than one type of non-putrescible waste, including commingled recyclables other than residential curbside recyclable material. This category includes construction and demolition waste but excludes Cleanup Materials Contaminated by Hazardous Substances, Source-Separated Recyclable Material, special waste, land clearing debris and yard debris.</li> </ol>

<b>3.0</b>	<b>AUTHORIZATIONS</b>	
<b>3.1</b>	<b>Purpose</b>	This section of the license describes the wastes that the Licensee is authorized to accept at the facility, and the waste-related activities the Licensee is authorized to perform at the facility.
<b>3.2</b>	<b>General conditions on solid waste</b>	The Licensee is authorized to accept at the facility only the solid wastes described in Section 3.0 of this license. The Licensee is prohibited from knowingly receiving any solid waste not authorized in this section.
<b>3.3</b>	<b>General conditions on activities</b>	The Licensee is authorized to perform at the facility only those waste-related activities that are described in Section 3.0 of this license.
<b>3.4</b>	<b>Acceptance and management of mixed non-putrescible waste</b>	<ol style="list-style-type: none"> <li>1. The Licensee is authorized to accept loads of mixed non-putrescible wastes for the purpose of conducting material recovery.</li> <li>2. All mixed non-putrescible waste tipping, storage, sorting and reloading activities must occur on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides. Unusually large vehicles (i.e., 30-foot tippers) may tip wastes outside, provided the tipped wastes are moved</li> </ol>



		<p>under cover prior to processing, within 12 hours of receipt, or by the end of the business day, whichever is earlier.</p> <p>3. The Licensee shall keep all mixed non-putrescible waste physically separated from and not mixed or commingled with source-separated recyclable materials, including wood waste, yard debris and other recyclables.</p>
<b>3.5</b>	<b>Material recovery required</b>	<p>1. The Licensee shall perform material recovery on mixed non-putrescible waste. The Licensee shall ensure that the facility is designed and operated to assure materials are recovered in a timely manner and to protect the quality of non-putrescible waste that has not yet undergone material recovery. The Licensee must perform recovery at no less than the minimum level stipulated in Metro Code Chapter 5.01.</p> <p>2. The Licensee shall take quarterly samples of processing residual that are statistically valid and representative of the facility's residual. Each sample required by this section shall weigh at least 300 pounds.</p>
<b>3.6</b>	<b>Management of processing residual from material recovery</b>	<p>1. The Licensee shall store all non-putrescible waste processing residual on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides, or alternatively, inside water-tight covered or tarped containers or within covered or tarped transport trailers.</p> <p>2. The Licensee shall keep all non-putrescible waste processing residual physically separated from and not mixed or commingled with source-separated recyclable materials, including wood waste, yard debris and other recyclables.</p>
<b>3.7</b>	<b>Acceptance of source-separated recyclable materials</b>	<p>The Licensee is authorized to accept homogenous loads of recyclable materials that have been source-separated by material type for the purpose of sorting, classifying, consolidating, bailing, temporary storage, transfer and other similar functions related to preparing these materials for reuse or recycling.</p>
<b>3.8</b>	<b>Acceptance and management of built-up roofing and roof tear off debris</b>	<p>1. The Licensee is authorized to accept built-up roofing waste and associated roof tear-off debris that is not asbestos-containing-material, as defined in OAR Chapter 340 Division 248.</p> <p>2. The Licensee shall accept only built-up roofing waste that has been tested and determined not to be asbestos-containing material prior to receipt at the facility.</p>



		<p>3. The Licensee shall accept and manage built-up roofing waste, as provided in the section, and in accordance with DEQ authorizations.</p>
<b>3.9</b>	<b>Processing of asphaltic roofing shingles and manufacturer's scrap</b>	<ol style="list-style-type: none"><li>1. The Licensee is authorized to grind asphaltic roofing shingles provided that, prior to grinding, the material has been tested and determined not to be asbestos-containing material as defined in OAR Chapter 340 Division 248.</li><li>2. The Licensee is authorized to grind asphaltic roofing shingles for delivery to hot mix asphalt production facilities or other useful purposes as described in an operating plan and approved in writing by the COO.</li><li>3. The Licensee shall perform all grinding of asphaltic roofing shingles in accordance with the requirements of the Oregon Department of Environmental Quality (DEQ).</li><li>4. All grinding of asphaltic roofing shingles must occur on an impervious surface and inside a roofed building that is enclosed on at least three sides.</li><li>5. The Licensee shall not accumulate more than 500 total tons of asphaltic roofing shingles and manufacturer's scrap on site at any one time.</li></ol>
<b>3.10</b>	<b>Acceptance and processing of yard debris</b>	<ol style="list-style-type: none"><li>1. The Licensee is authorized to accept source-separated yard debris that has not reached a state of decomposition sufficient to produce malodors detectable beyond the boundaries of the facility.</li><li>2. The Licensee may accept yard debris only for processing and reloading to authorized composting facilities, paper production facilities, to facilities with industrial boilers for use as hogged fuel or other useful purposes as described in an operations plan and approved by the COO.</li><li>3. All processing of yard debris must occur on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides.</li></ol>
<b>3.11</b>	<b>Acceptance and processing of land clearing debris</b>	<ol style="list-style-type: none"><li>1. The Licensee is authorized to accept land clearing debris (e.g. brush and stumps).</li><li>2. Land clearing debris may be accepted for processing and reloading to authorized composting facilities, paper production facilities, to facilities with industrial boilers for use as hogged fuel or other useful purposes as described in an operations plan and approved by the COO.</li></ol>



		<p>3. All processing of land clearing debris must occur on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides.</p>
<b>3.12</b>	<b>Acceptance and processing of untreated wood</b>	<p>1. The Licensee is authorized to accept for processing and reloading, source-separated, untreated and unpainted wood waste (e.g. untreated lumber and wood pallets).</p> <p>2. The Licensee may accept untreated wood waste only for processing, and reloading to authorized composting facilities, paper production facilities, facilities with industrial boilers for use as hogged fuel or other useful purposes as described in an operations plan and approved by the COO.</p> <p>3. All processing of untreated wood must occur on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides.</p>
<b>3.13</b>	<b>Acceptance and processing of painted wood</b>	<p>1. The Licensee is authorized to accept painted wood waste for the production of hogged fuel.</p> <p>2. The Licensee shall keep painted wood waste separate from yard debris and untreated wood waste destined for composting or mulch. The Licensee shall not use or incorporate painted wood as mulch, animal bedding, or compost feedstock.</p> <p>3. All processing of painted wood must occur on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides.</p>
<b>3.14</b>	<b>Acceptance and management of preservative-treated wood</b>	<p>1. The Licensee is authorized to accept incidental quantities of preservative-treated wood waste, other than creosote-treated wood waste, that may be present in loads comprised predominantly of clean or painted wood waste.</p> <p>2. The Licensee shall not incorporate preservative-treated wood waste, such as wood treated with Pentachlorophenol (PCP or "penta") and Copper Chromium Arsenic (CCA), into mulch, animal bedding, or compost feedstock.</p> <p>3. All processing of preservative-treated wood must occur on an impervious surface (e.g. asphalt or concrete) and inside a roofed building that is enclosed on at least three sides.</p>
<b>3.15</b>	<b>Production of hogged fuel</b>	<p>1. As authorized by Section 3.0 of this license, the Licensee is authorized to accept process, and reload only yard debris, land clearing debris, untreated wood, painted wood, and treated wood for delivery to facilities</p>





		<p>with industrial boilers for use as hogged fuel or other useful purposes as described in an operations plan and approved by the COO.</p> <p>2. Licensee is prohibited from mixing any other solid waste with the wood wastes described above in Section 3.15.1 for the production of hogged fuel.</p>

<b>4.0</b>	<b>LIMITATIONS AND PROHIBITIONS</b>	
<b>4.1</b>	<b>Purpose</b>	This section of the license describes limitations and prohibitions on the wastes handled at the facility and activities performed at the facility.
<b>4.2</b>	<b>Prohibited waste</b>	The Licensee shall not knowingly receive, process, reload or dispose of any solid waste not authorized in this license. The Licensee shall not knowingly accept or retain any material amounts of the following types of wastes: non-putrescible waste other than that specifically allowed in Section 3.0 of this license, putrescible waste, special wastes as defined in Metro Code Chapter 5.01, creosote-treated wood or timbers, materials contaminated with or containing asbestos; lead acid batteries; liquid waste for disposal; vehicles; infectious, biological or pathological waste; radioactive waste; hazardous waste; any waste prohibited by the DEQ.
<b>4.3</b>	<b>Prohibition on mixing</b>	The Licensee shall not mix any source-separated recyclable materials, source-separated yard debris or wood wastes brought to the facility with any other solid wastes.
<b>4.4</b>	<b>Prohibition of size reduction on non-putrescible waste</b>	Except as provided in Section 3.0 of this license, the Licensee shall not crush, grind or otherwise reduce the size of non-putrescible waste except when such size reduction constitutes a specific step in the facility's material recovery operations, reload operations, or processing residual consolidation or loading operations, and such size reduction is described in an operating plan and approved in writing by the COO.
<b>4.5</b>	<b>No disposal of recyclable materials</b>	The Licensee shall not transfer source-separated recyclable materials to a disposal site.
<b>4.6</b>	<b>Composting prohibited</b>	The Licensee shall not keep yard debris on site long enough for more than negligible biological decomposition to begin.



4.7	<b>Limits not exclusive</b>	This License shall not be construed to limit, restrict, curtail, or abrogate any limitation or prohibition contained elsewhere in this license document, in Metro Code, or in any federal, state, regional or local government law, rule, regulation, ordinance, order or permit.
4.8	<b>Prohibition of grinding</b>	The Licensee is prohibited from grinding wood, wood waste or other materials during the months of May, June, July, August and September, unless the Licensee loads all ground wood, wood waste and other ground materials directly into containers or trailers within a roofed-structure that is enclosed on at least three sides and located at the north property (Tax Lot ID 1N1E19DB-01200). Alternatively, the licensee may consolidate and reload wood, wood waste and other materials without grinding the material. Any other method suggested by the Licensee must be agreed upon in writing by the COO.

5.0	<b>OPERATING CONDITIONS</b>	
5.1	<b>Purpose and general performance goals</b>	<p>This section of the license describes criteria and standards for the operation of the facility. The Licensee shall meet the following general performance goals:</p> <ul style="list-style-type: none"> <li>a) Environment. The Licensee shall design and operate the facility to preclude the creation of undue threats to the environment including, but not limited to, stormwater or groundwater contamination, air pollution, and improper acceptance and management of hazardous waste asbestos and other prohibited wastes.</li> <li>b) Health and safety. The Licensee shall design and operate the facility to preclude the creation of conditions that may degrade public health and safety including, but not limited to, fires, vectors, pathogens and airborne debris.</li> <li>c) Nuisances. The Licensee shall design and operate the facility to preclude the creation of nuisance conditions including, but not limited to, litter, dust, odors, and noise.</li> </ul>
5.2	<b>Qualified operator</b>	1. The Licensee shall, during all hours of operation, provide an operating staff employed by the facility, and qualified and competent to carry out the functions required by this license and to otherwise ensure compliance with Metro Code Chapter 5.01.



		<ol style="list-style-type: none"><li>2. Facility personnel, as relevant to their job duties and responsibilities, shall be familiar with the relevant provisions of this license and the relevant procedures contained within the facility's operating plan.</li><li>3. A qualified operator must be an employee of the facility with training and authority to reject prohibited waste that is discovered during load checks and to properly manage prohibited waste that is inadvertently received.</li></ol>
<b>5.3</b>	<b>Fire prevention</b>	The Licensee shall provide fire prevention, protection, and control measures, including but not limited to, adequate water supply for fire suppression, and the isolation of potential heat sources and/or flammables from the processing and storage areas.
<b>5.4</b>	<b>Adequate vehicle accommodation</b>	The Licensee shall: <ol style="list-style-type: none"><li>1. Provide access roads of sufficient capacity to adequately accommodate all on-site vehicular traffic. Access roads shall be maintained to allow the orderly egress and ingress of vehicular traffic when the facility is in operation, including during inclement weather.</li><li>2. Take reasonable steps to notify and remind persons delivering solid waste to the facility that vehicles shall not park or queue on public streets or roads except under emergency conditions or as provided by local traffic ordinances.</li><li>3. Post signs to inform customers not to queue on public roadways.</li><li>4. Provide adequate off-street parking and queuing for vehicles, including adequate space for on-site tarping and untarping of loads.</li></ol>
<b>5.5</b>	<b>Managing prohibited wastes</b>	<ol style="list-style-type: none"><li>1. The Licensee shall reject prohibited waste upon discovery and shall properly manage and dispose of prohibited waste when inadvertently received.</li><li>2. The Licensee shall implement a load-checking program to prevent the acceptance of waste that is prohibited by the license. This program must include at a minimum:<ol style="list-style-type: none"><li>a) Visual inspection. As each load is tipped, a qualified operator shall visibly inspect the load to prevent the acceptance of waste that is prohibited by the license.</li><li>b) Containment area. A secured or isolated containment area for the storage of prohibited wastes that are inadvertently received. Containment areas shall be covered and enclosed to prevent leaking</li></ol></li></ol>



		<p>and contamination.</p> <p>c) Record maintenance. Records of the training of personnel in the recognition, proper handling, and disposition of prohibited waste shall be maintained in the operating record and be available for review by Metro.</p> <p>3. Upon discovery, the Licensee shall remove all prohibited or unauthorized wastes or manage the waste in accordance with DEQ requirements and procedures established in the operating plan. All such wastes the Licensees inadvertently receives shall be removed from the site and transported to an appropriate destination within 90 days of receipt, unless required to be removed earlier by the DEQ or local government.</p>
<b>5.6</b>	<b>Storage and exterior stockpiles</b>	<p>The Licensee shall:</p> <ol style="list-style-type: none"><li>1. Manage, contain, and remove at sufficient frequency stored materials and solid wastes to avoid creating nuisance conditions, vector or bird attraction or harborage, or safety hazards;</li><li>2. Maintain storage areas in an orderly manner and keep the areas free of litter;</li><li>3. Position exterior stockpiles within footprints identified on the facility site plan or operating plan; and</li><li>4. Not stockpile recovered or source-separated materials for longer than 180 days (6 months).</li></ol>
<b>5.7</b>	<b>Dust, airborne debris and litter</b>	<ol style="list-style-type: none"><li>1. The Licensee shall operate the facility in a manner that minimizes and mitigates the generation of dust, airborne debris and litter, and shall prevent its migration beyond property boundaries.</li><li>2. The Licensee shall:<ol style="list-style-type: none"><li>a) Take reasonable steps, including signage, to notify and remind persons delivering solid waste to the facility that all loads must be suitably secured to prevent any material from blowing off the load during transit.</li><li>b) Maintain and operate all vehicles and devices transferring or transporting solid waste from the facility to prevent leaking, spilling or blowing of solid waste on-site or while in transit.</li><li>c) Maintain and operate all access roads and receiving, processing (including grinding), storage, and reload areas in such a manner as to minimize dust and debris generated on-site and prevent such dust and</li></ol></li></ol>



		<p>debris from blowing or settling off-site.</p> <p>d) Keep all areas within the site and all vehicle access roads within ¼ mile of the site free of litter and debris generated directly or indirectly as a result of the facility's operation.</p> <p>e) Maintain on-site facility access roads to prevent or control dust and to prevent or control the tracking of mud, gravel or other debris off-site.</p> <p>Provide access to the facility for the purpose of uncovered load enforcement. During all times that solid waste or recyclable materials are being accepted, authorized representatives of Metro, including law enforcement personnel on contract to Metro, shall be permitted access to the premises of the facility for the purpose of making contact with individuals they have observed transporting uncovered loads of solid waste or recyclable materials on a public road right-of-way in violation of Metro Code Section 5.09.040.</p>
<b>5.8</b>	<b>Odor</b>	<p>1. The Licensee shall operate the facility in a manner that prevents the generation of odors that are detectable off-site.</p> <p>2. The Licensee shall establish and follow procedures in the operating plan for minimizing odor at the facility.</p>
<b>5.9</b>	<b>Vectors (e.g. birds, rodents, insects)</b>	<p>1. The Licensee shall operate the facility in a manner that is not conducive to the harborage of rodents, birds, insects, or other vectors capable of transmitting, directly or indirectly, infectious diseases to humans or from one person or animal to another.</p> <p>2. If vectors are present or detected at the facility, the Licensee shall implement vector control measures.</p>
<b>5.10</b>	<b>Noise</b>	<p>The Licensee shall operate the facility in a manner that prevents the creation of noise sufficient to cause adverse off-site impacts and to the extent necessary to meet applicable regulatory standards and land-use regulations.</p>
<b>5.11</b>	<b>Water quality</b>	<p>The Licensee shall operate the facility consistent with an approved DEQ stormwater management plan, or equivalent, and shall:</p> <p>a) Operate and maintain the facility to prevent contact of solid wastes with storm water runoff and precipitation; and</p> <p>b) Dispose of or treat water contaminated by solid waste generated onsite in a manner complying with</p>



		local, state, and federal laws and regulations.
<b>5.12</b>	<b>Access control</b>	<ol style="list-style-type: none"><li>1. The Licensee shall control access to the facility as necessary to prevent unauthorized entry and dumping.</li><li>2. The Licensee shall respond to all nuisance complaints in timely manner (including, but not limited to, blowing debris, fugitive dust or odors, noise, traffic, and vectors), and shall keep a record of such complaints and any action taken to respond to the complaints, including actions to remedy the conditions that caused the complaint.</li><li>2. If the facility receives a complaint, the Licensee shall:<ol style="list-style-type: none"><li>a) Attempt to respond to that complaint within one business day, or sooner as circumstances may require, and retain documentation of its attempts (whether successful or unsuccessful); and</li><li>b) Log all such complaints as provided by the recordkeeping and reporting standards. <b>6.0</b>	<b>OPERATING PLAN</b>	
<b>6.1</b>	<b>Purpose</b>	This section lists the requirements associated with preparing and implementing a facility operating plan, and lists the procedures that must be included in the required facility operating plan.
<b>6.2</b>	<b>Plan compliance</b>	The Licensee must operate the facility in accordance with an operating plan approved in writing by the COO. The operating plan must include sufficient detail to demonstrate that the facility will be operated in compliance with this license. The Licensee may amend or revise the operating plan from time to time, subject to written approval by the COO.
<b>6.3</b>	<b>Plan maintenance</b>	The Licensee must revise the operating plan as necessary to keep it current with facility conditions, procedures, and requirements. The Licensee must submit revisions of the operating plan to the COO for written approval prior to implementation.
<b>6.4</b>	<b>Access to operating plan</b>	The Licensee shall maintain a copy of the operating plan on the facility premises and in a location where facility personnel and Metro representatives have ready access to it.
<b>6.5</b>	<b>Procedures for inspecting loads</b>	The operating plan shall establish: <ul style="list-style-type: none"><li>a) Procedures for inspecting incoming loads for the presence of prohibited or unauthorized wastes;</li><li>b) A set of objective criteria for accepting and rejecting loads; and</li><li>c) An asbestos testing protocol for all material that appears as if it may contain asbestos.</li></ul>
<b>6.6</b>	<b>Procedures for processing and storage of loads</b>	The operating plan shall establish procedures for: <ul style="list-style-type: none"><li>a) Processing authorized solid wastes;</li><li>b) Reloading and transfer of authorized solid wastes;</li><li>c) Managing stockpiles to ensure that they remain within the authorized volumes and pile heights;</li><li>d) Storing authorized solid wastes; and</li></ul>



		e) Minimizing storage times and avoiding delay in processing of authorized solid wastes.
6.7	<b>Procedures for managing prohibited wastes</b>	The operating plan shall establish procedures for managing, reloading, and transporting to appropriate facilities or disposal sites each of the prohibited or unauthorized wastes if they are discovered at the facility. In addition, the operating plan shall establish procedures and methods for notifying generators not to place hazardous wastes or other prohibited wastes in drop boxes or other collection containers destined for the facility.
6.8	<b>Procedures for odor prevention</b>	The operating plan shall establish procedures for preventing all objectionable odors generated at the facility from being detected off the premises of the facility. The plan must include: <ul style="list-style-type: none"><li>a) A management plan that will be used to monitor and manage all odors of any derivation including malodorous loads delivered to the facility; and</li><li>b) Procedures for receiving and recording odor complaints, immediately investigating any odor complaints to determine the cause of odor emissions, and remedying promptly any odor problem at the facility.</li></ul>
6.9	<b>Procedures for dust prevention</b>	The operating plan shall establish procedures for preventing dust from blowing off the premises of the facility. The plan must include: <ul style="list-style-type: none"><li>a) A management plan that will be used to monitor and manage dust of any derivation; and</li><li>b) Procedures for receiving and recording dust complaints, immediately investigating any dust complaints to determine the cause of dust emissions, and remedying promptly any dust problem at the facility.</li></ul>
6.10	<b>Procedures for emergencies</b>	The operating plan shall establish procedures to be followed in case of fire or other emergency.
6.11	<b>Procedures for nuisance complaints</b>	1. For every nuisance complaint (e.g. odor, dust, vibrations, litter) received, the Licensee shall record: <ul style="list-style-type: none"><li>a) The nature of the complaint;</li><li>b) The date the complaint was received;</li><li>c) The name, address and telephone number of the person or persons making the complaint; and</li><li>d) Any actions taken by the operator in response to the</li></ul>





		<p>complaint (whether successful or unsuccessful).</p> <p>2. The Licensee shall make records of such information available to Metro upon request. The Licensee shall retain each complaint record for a period of not less than one year.</p>
<b>6.12</b>	<b>Closure protocol</b>	<p>The Licensee shall establish protocol for closure and restoration of the site in the event of a cessation of operations as provided in Metro Code Chapter 5.01. The plan shall establish procedures for:</p> <ul style="list-style-type: none"> <li>a) Short term closure (duration of time that is more than seven consecutive days but less than 30 consecutive days in length); and</li> <li>b) Long term closure (duration of time that is 30 consecutive days or more in length).</li> </ul>
<b>6.13</b>	<b>Financial assurance</b>	<p>The Licensee shall maintain financial assurance in an amount adequate for the cost of the facility's closure and in a form approved by Metro for the term of this license, as provided in Metro Code Chapter 5.01.</p>

<b>7.0</b>	<b>FEES AND RATE SETTING</b>	
<b>7.1</b>	<b>Purpose</b>	This section of the license specifies fees payable by the Licensee, and describes rate regulation by Metro.
<b>7.2</b>	<b>Annual fee</b>	The Licensee shall pay an annual license fee, as established in Metro Code Chapter 5.01. Metro reserves the right to change the license fee at any time by action of the Metro Council.
<b>7.3</b>	<b>Rates not regulated</b>	The tipping fees and other rates charged at the facility are exempt from rate regulation by Metro.
<b>7.4</b>	<b>Metro fee imposed on disposal</b>	The Licensee is liable for payment of the Metro Regional System Fee, as provided in Metro Code Title V, and the Metro Excise Tax, as provided in Metro Code Title VII, on all solid wastes delivered to a disposal site.

<b>8.0</b>	<b>RECORD KEEPING AND REPORTING</b>	
<b>8.1</b>	<b>Purpose</b>	This section of the license describes record keeping and reporting requirements. The Licensee shall effectively monitor facility operation and maintain accurate records of the information described in this section.



<b>8.2</b>	<b>Record keeping requirements</b>	The Licensee shall keep and maintain accurate records of the amount of all solid waste and materials the Licensee receives, recovers, recycles, reloads and disposes as authorized under Section 3.0 of this license. These records must include the information specified in <u>Reporting Requirements and Data Standards for Metro Solid Waste Licensees, Franchisees, and Parties to Designated Facility Agreements</u> .
<b>8.3</b>	<b>Reporting requirements</b>	Licensee shall transmit to Metro records required under Section 8.0 no later than fifteen days following the end of each month in electronic format prescribed by Metro.
<b>8.4</b>	<b>Hauler account number listing</b>	Within 5 business days of Metro's request, Licensee shall provide Metro with a computer listing that cross references the incoming hauler account Number with the hauling company's name and address.
<b>8.5</b>	<b>Transactions based on scale weights</b>	Except for minimum fee transactions for small, light-weight loads, the Licensee shall record each transaction electronically based on actual and accurate scale weights using the Licensee's on-site scales.
<b>8.6</b>	<b>DEQ submittals</b>	The Licensee shall provide Metro with copies of all correspondence, exhibits, or documents submitted to the DEQ relating to the terms or conditions of the DEQ solid waste permit or this license within two business days of providing such information to DEQ.
<b>8.7</b>	<b>Copies of enforcement actions provided to Metro</b>	The Licensee shall send to Metro, upon receipt, copies of any notice of violation or non-compliance, citation, or any other similar enforcement actions issued to the Licensee by any federal, state, or local government other than Metro, and related to the operation of the facility.
<b>8.8</b>	<b>Unusual occurrences</b>	<ol style="list-style-type: none"><li>1. The Licensee shall keep and maintain accurate records of any unusual occurrences (such as fires or any other significant disruption) encountered during operation, and methods used to resolve problems arising from these events, including details of all incidents that required implementing emergency procedures.</li><li>2. If a breakdown of the Licensee's equipment occurs that will substantially impact the ability of the facility to remain in compliance, or create off-site impacts, the Licensee shall notify Metro within 24-hours.</li><li>3. The Licensee shall report any facility fires, accidents, emergencies, and other significant incidents to Metro at (503) 234-3000 within 12 hours of the discovery of their</li></ol>



		occurrence.
<b>8.9</b>	<b>Changes in ownership</b>	The Licensee must, in accordance with Metro Code Chapter 5.01, submit a new license application to Metro if the Licensee proposes to transfer ownership or control of (1) the license, (2) the facility property, or (3) change the name and address of the operator.
<b>8.10</b>	<b>Material recovery reporting</b>	The Licensee shall provide the results of its quarterly sampling of processing residual, as provided in Section 3.5 of this license, to Metro as a component of its monthly report no later than fifteen days following the end of the each quarter in a format prescribed by Metro.

<b>9.0</b>	<b>INSURANCE REQUIREMENTS</b>	
<b>9.1</b>	<b>Purpose</b>	This section describes the types of insurance that the Licensee shall purchase and maintain at the Licensee's expense, covering the Licensee, its employees, and agents. Licensee shall provide Metro with certification of all insurance coverage required in Section 9.0.
<b>9.2</b>	<b>General liability</b>	The Licensee shall carry the most recently approved ISO (Insurance Services Office) Commercial General Liability policy, or its equivalent, written on an occurrence basis, with limits not less than \$1,000,000 per occurrence. The policy will include coverage for bodily injury, property damage, personal injury, death, contractual liability, premises and products/completed operations. Contractor's coverage will be primary as respects Metro.
<b>9.3</b>	<b>Automobile</b>	The Licensee shall carry automobile bodily injury and property damage liability insurance with a combined single limit of \$1,000,000.
<b>9.4</b>	<b>Additional insureds</b>	Metro, its elected officials, departments, employees, and agents shall be named as ADDITIONAL INSUREDS on the Commercial General Liability and automobile insurance policies.
<b>9.5</b>	<b>Worker's Compensation Insurance</b>	The Licensee, its subcontractors, if any, and all employers working under this license, are subject employers under the Oregon Workers' Compensation Law and shall comply with ORS 656.017, which requires them to provide Workers' Compensation coverage for all their subject workers. The Licensee shall provide Metro with certification of Workers' Compensation insurance including employer's liability. If the Licensee has no employees and will perform the work



		without the assistance of others, a certificate to that effect may be attached in lieu of the certificate showing current Workers' Compensation.
<b>9.6</b>	<b>Notification</b>	The Licensee shall give at least 30 days written notice to the Solid Waste Compliance and Cleanup Director of any lapse or proposed cancellation of insurance coverage.

<b>10.0</b>	<b>ENFORCEMENT</b>	
<b>10.1</b>	<b>Generally</b>	Enforcement of this license shall be as specified in Metro Code Chapter 5.01.
<b>10.2</b>	<b>Authority vested in Metro</b>	The power and right to regulate, in the public interest, the exercise of the privileges granted by this license shall at all times be vested in Metro. Metro reserves the right to establish or amend rules, regulations or standards regarding matters within Metro's authority, and to enforce all such requirements against Licensee.
<b>10.3</b>	<b>No Enforcement Limitations</b>	This license shall not be construed to limit, restrict, curtail, or abrogate any enforcement provision contained in Metro Code or administrative procedures adopted pursuant to Metro Code Chapter 5.01, nor shall this license be construed or interpreted so as to limit or preclude Metro from adopting ordinances that regulate the health, safety, or welfare of any person or persons within the District, notwithstanding any incidental impact that such ordinances may have upon the terms of this license or the Licensee's operation of the facility.
<b>10.4</b>	<b>Penalties</b>	<ol style="list-style-type: none"> <li>1. Each violation of a license condition shall be punishable by fines as established in Metro Code Chapter 5.01.</li> <li>2. Each day a violation continues constitutes a separate violation.</li> <li>3. Notwithstanding Section 10.4.1 above, if the Licensee violates the conditions stipulated in Section 3.4.2 or Section 5.5.2 during the term of this license, Metro will assess a base penalty of \$250 for each violation. This \$250 base penalty can only be contested upon issuance of this license and will be assessed in addition to any penalty calculated by Metro in the normal course of its enforcement action.</li> <li>4. Notwithstanding Section 10.4.1 above, if the Licensee violates the conditions stipulated in Section 5.7.1 during the term of this license, Metro will assess a base penalty</li> </ol>



		of \$500 for each violation. This \$500 base penalty can only be contested upon issuance of this license and will be assessed in addition to any penalty calculated by Metro in the normal course of its enforcement action.

<b>11.0</b>	<b>AMENDMENT, MODIFICATION, SUSPENSION, AND REVOCATION</b>	
<b>11.1</b>	<b>Amendment</b>	At any time during the term of the license, either the COO or the Licensee may propose amendments to this license. The COO has the authority to approve or deny any such amendments provided that the activities authorized in the amended license do not require a Metro Solid Waste Facility Franchise under Metro Code Chapter 5.01. When applicable, the Licensee shall comply with Metro Code Chapter 5.01. No amendment pursuant to this section shall be effective unless in writing and executed by the COO.
<b>11.2</b>	<b>Modification, suspension or revocation by Metro</b>	The COO may, at any time before the expiration date, modify, suspend, or revoke this license in whole or in part, in accordance with Metro Code Chapter 5.01, for reasons including but not limited to: <ul style="list-style-type: none"> <li>a) Violation of the terms or conditions of this license, Metro Code, or any applicable statute, rule, or standard;</li> <li>b) Changes in local, regional, state, or federal laws or regulations that should be specifically incorporated into this license;</li> <li>c) Failure to disclose fully all relevant facts;</li> <li>d) A significant release into the environment from the facility;</li> <li>e) Significant change in the character of solid waste received or in the operation of the facility;</li> <li>f) Any change in ownership or control, excluding transfers among subsidiaries of the Licensee or Licensee's parent corporation;</li> <li>g) A request from the local government stemming from impacts resulting from facility operations; and</li> <li>h) Compliance history of the Licensee.</li> </ul>

<b>12.0</b>	<b>GENERAL OBLIGATIONS</b>	
<b>12.1</b>	<b>Compliance with law</b>	The Licensee shall fully comply with all applicable local, regional, state and federal laws, rules, regulations, ordinances, orders and permits pertaining in any manner



		<p>to this license, including all applicable Metro Code provisions and administrative procedures adopted pursuant to Chapter 5.01 whether or not those provisions have been specifically mentioned or cited herein. All conditions imposed on the operation of the facility by federal, state, regional or local governments or agencies having jurisdiction over the facility shall be deemed part of this license as if specifically set forth herein. Such conditions and permits include those cited within or attached as exhibits to the license document, as well as any existing at the time of the issuance of the license but not cited or attached, and permits or conditions issued or modified during the term of the license.</p>
<b>12.2</b>	<b>Deliver waste to appropriate destinations</b>	<p>The Licensee shall ensure that solid waste transferred from the facility goes to the appropriate destinations under Metro Code chapters 5.01 and 5.05, and under applicable local, state and federal laws, rules, regulations, ordinances, orders and permits;</p>
<b>12.3</b>	<b>Right of inspection and audit</b>	<ol style="list-style-type: none"><li>1. Authorized representatives of Metro may take photographs, collect samples of materials, and perform such inspection or audit as the COO deems appropriate, and shall be permitted access to the premises of the facility at all reasonable times during business hours with or without notice or at such other times upon giving reasonable advance notice (not less than 24 hours).</li><li>2. Metro inspection reports, including site photographs, are public records subject to disclosure under Oregon Public Records Law.</li><li>3. Subject to the confidentiality provisions in Section 12.4 of this license, Metro's right to inspect shall include the right to review all information from which all required reports are derived including all books, maps, plans, income tax returns, financial statements, contracts, and other similar written materials of Licensee that are directly related to the operation of the Facility.</li><li>4. The Licensee shall permit access to the facility premises to authorized representatives of Metro, including personnel on contract to Metro, at all reasonable times during business hours with or without notice to determine whether the Licensee meets the minimum level of recovery as provided in Section 3.5 of this license. <b>12.4</b>	<b>Confidential information</b>	<p>The Licensee may identify as confidential any reports, books, records, maps, plans, income tax returns, financial statements, contracts and other similar written materials of the Licensee that are directly related to the operation of the facility and that are submitted to or reviewed by Metro. The Licensee shall prominently mark any information that it claims confidential with the mark "CONFIDENTIAL" prior to submittal to or review by Metro. Metro shall treat as confidential any information so marked and will make a good faith effort not to disclose such information unless Metro's refusal to disclose such information would be contrary to applicable Oregon law, including, without limitation, ORS Chapter 192. Within five (5) days of Metro's receipt of a request for disclosure of information identified by Licensee as confidential, Metro shall provide Licensee written notice of the request. The Licensee shall have three (3) days within which time to respond in writing to the request before Metro determines, at its sole discretion, whether to disclose any requested information. The Licensee shall pay any costs incurred by Metro as a result of Metro's efforts to remove or redact any such confidential information from documents that Metro produces in response to a public records request. This Section 12.0 shall not limit the use of any information submitted to or reviewed by Metro for regulatory purposes or in any enforcement proceeding. In addition, Metro may share any confidential information with representatives of other governmental agencies provided that, consistent with Oregon law, such representatives agree to continue to treat such information as confidential and make good faith efforts not to disclose such information.</p>
<b>12.5</b>	<b>Compliance by agents</b>	<p>The Licensee shall be responsible for ensuring that its agents and contractors operate in compliance with this license.</p>
