

Community Advisory Committee (CAC) During SW Corridor Project Development

MEMBER RECRUITMENT

Committee Purpose

As the <u>Southwest Corridor Light Rail Project</u> moves from a broader planning process into a more detailed design phase, project partners recognize the important continued and evolving role of community engagement.

As part of a larger community engagement program, this Southwest Corridor Light Rail Project Community Advisory Committee (SWC CAC) will advise the project staff and Steering Committee for approximately two years. The project team will consult with the CAC when weighing technical, regulatory and cost considerations, recognizing that decisions must be grounded in community values and experience.

CAC Members will:

- Serve as a sounding board for design options affecting light rail alignment, station locations, sidewalk and roadway improvements, etc. Review technical information, discuss community interests and concerns, and provide feedback to project staff.
- Serve as representatives of broader communities. Communicate regularly with the groups that members represent and help facilitate two-way communication between the project staff and members' communities.
- Participate in some community meetings outside CAC meetings

Project staff will:

- Provide understandable technical information about proposed designs.
- Report on how proposed designs reflect community input received from other engagement efforts, from previous phases, and from other projects and programs.
- Report on how input from the CAC and other community engagement efforts influence ongoing designs.
- Facilitate meetings

For example, during the first year, CAC topics may include:

- Design refinements identified in the Locally Preferred Alternative (LPA) (e.g., Taylors Ferry, 68th Avenue)
- Station optimization (refining station locations and Park & Ride footprints)
- Marquam Hill connector
- PCC Shuttle and 53rd Avenue improvements
- Station access projects (improvements for people biking and walking)
- Coordination with parallel projects (e.g., Ross Island Bridgehead, Equitable Housing Strategy)

MEMBER RECRUITMENT

Representation

The SWC CAC is expected to include 12 to 16 members, aiming to include individuals with a connection to places in the corridor and who represent one or more of the following categories:

- Transit riders
- Residents (renters and owners)
- Major employers/institutions
- Small businesses
- Property owners
- Students / youth
- · Communities of color
- Affordable housing interests
- Accessibility interests (seniors, people with disabilities)
- People who walk, bike and drive

Responsibilities

- Support the process to date and the assumptions in the LPA adopted in 2018
- Work collaboratively toward maximizing the benefits and minimizing the impacts of the project within technical, regulatory and cost constraints.
- Communicate regularly with interested people within your community and share the feedback received at committee meetings
- Attend standing committee meetings and participate in committee-sponsored activities
- Be prepared for each meeting by reviewing and reading meeting materials and documents beforehand
- Honor group participation guidelines

Commitment

- Two-year commitment to begin in January 2019. This duration could change depending on funding timelines.
- Three to five hours per month, including a standing 90-minute meeting (evenings first Thursday of most months), meeting preparation, coordination with those you represent and other committee activities
- Ability to travel to meeting locations within the corridor. Locations will be accessible by transit.
- Meetings will include food and transit passes for members
