Program Objectives

- Build civic and community engagement capacity for Black, Indigenous and communities of color;
- Strategically invest in underserved geographic areas and communities facing the highest barriers to civic participation;
- Support equitable decision-making across the solid waste system and in other Metro programmatic areas;
- Build long-term, trusted relationships with community-based organizations and the Black, Indigenous, and other communities of color they serve;
- Bring more BIPOC leaders into Metro decision-making processes and committees.

Program structure

- Housed in Diversity, Equity and Inclusion office within the Office of the COO
- \$400,000 per year in grants
- Three year grant cycles
- Individual grants will range from \$60,000-\$100,000/year
- Goal: expand to add program resources to support cohort

Who is eligible?

- Registered 501(C)(3)s or organizations with a (C)3 fiscal sponsor
- Primarily serve and are accountable to Black, Indigenous and communities of color
- Have some experience with civic engagement, community organizing, advocacy, etc.

Preferred: 1+ fulltime staff and/or \$80,000+ annual revenue

Grant Tracks

General Capacity Building

- Allows alignment with any Metro programmatic area
- Eligible uses:
 - Hiring engagement staff
 - Training and education
 - Leadership development
 - Member recruitment
 - General operations
- Ineligible uses:
 - Political campaigning

Garbage and Recycling System Capacity

- Tailored to advance inclusive decisionmaking in the garbage and recycling system
- Similar eligible uses, but focused on touch points with garbage and recycling system

Application Process

Application process

- Two-step process: letter of interest + grant application
- Goal: reduce administrative burden
- Scope refinement over time
- Technical assistance available by request
- FAQs will be updated weekly

Important Details

- Letters of interests are due March 31, 11:59pm.
- Submit via Metro website form or email to Program Contact.
- Written, visual and audio submissions are accepted.
- More than one letter of interest allowed.

Timeline

Application process

March 31, 2021: Letters of interest due

April 9, 2021: Finalists announced

May 7, 2021: Finalists' applications due

May 28, 2021: Grantees notified

Selection Process

Selection Criteria Summary

- Builds capacity in **underserved areas** of the region: Clackamas, Washington or East Multnomah counties.
- Supports the development of new and/or deeper relationships and trust between CBOs and the Black, Indigenous and communities of color they serve.
- Increases organizational and community capacity to engage with Metro decision-making processes, advisory bodies, planning processes, projects and programs, and engagement activities.
- Meaningfully **adds capacity** and/or flexibility to an organization's civic or community engagement efforts.
- Supports more **inclusive decision-making** and increases equity across the garbage and recycling system.

Civic Engagement Grants Advisory Group

- Metro staff from DEI, Council office, WPES and Parks & Nature
- One to two Committee on Racial Equity members
- One to two Regional Waste Advisory Council members
- Up to three community leaders with civic engagement backgrounds

Grant award process

- Collaboratively created grant agreements
- Integrated reporting
- Yearly evaluation and rescoping
- Bi-annual disbursements
- Strong relationship with Council







A blueprint for policy direction and roles and responsibilities

The means by which we comply with Oregon statute



Plan principles

Community Restoration

Take action to repair past harm and disproportionate impacts caused by the regional solid waste system.

Community Partnerships

Develop authentic partnerships and community trust to advance the plan vision.

Community Investment

Emphasize resource allocation to communities of color and historically marginalized communities within the regional solid waste system.




