<b>2.0</b>	<b>CONDITIONS AND DISCLAIMERS</b>	
<b>2.1</b>	<b>Guarantees</b>	This license does not vest any right or privilege in the licensee to receive specific quantities of solid waste at the direction of Metro during the term of the license.
<b>2.2</b>	<b>Non-exclusive license</b>	This license does not limit Metro from granting other solid waste licenses within Metro's jurisdictional boundary.
<b>2.3</b>	<b>Property rights</b>	This license does not convey any property rights in either real or personal property.
<b>2.4</b>	<b>No recourse</b>	The licensee will have no recourse against Metro or its officials, agents or employees for any loss, costs, expense or damage arising out of any provision or requirement of this license or because of the enforcement of the license or in the event Metro determines that the license or any part thereof is invalid.
<b>2.5</b>	<b>Indemnification</b>	The licensee must indemnify Metro, the Metro Council, the Chief Operating Officer and any of their employees or agents and save them harmless from any and all loss, damage, claim, expense including attorney's fees, or liability related to or arising out of the granting of this



		license or the licensee's performance of or failure to perform any of its obligations under the license or Metro Code Chapter 5.01, including without limitation patent infringement and any claims or disputes involving subcontractors.
<b>2.6</b>	<b>Waivers</b>	To be effective, a waiver of any terms or conditions of this license must conform with Section 11.0 and be in writing and signed by Metro.
<b>2.7</b>	<b>Effect of waiver</b>	Waiver of a term or condition of this license does not waive nor prejudice Metro's right otherwise to require subsequent performance of the same term or condition or any other term or condition.
<b>2.8</b>	<b>Enforceability</b>	If a court of competent jurisdiction determines that any provision of this license is invalid, illegal or unenforceable in any respect, the validity of the remaining provisions contained in this license will not be affected.
<b>2.9</b>	<b>License not a waiver</b>	This license does not relieve any owner, operator or the licensee from the obligation to obtain all required permits, licenses or other clearances and to comply with all orders, laws, regulations, reports or other requirements of other regulatory agencies.
<b>2.10</b>	<b>License not limiting</b>	This license does not limit the power of a federal, state or local agency to enforce any provision of law relating to the facility.
<b>2.11</b>	<b>Definitions</b>	Unless otherwise specified, all other terms are as defined in Metro Code Chapter 5.00.

<b>3.0</b>	<b>AUTHORIZATIONS</b>	
<b>3.1</b>	<b>General conditions on solid waste</b>	The licensee is authorized to accept at the facility only the solid wastes described in Section 3.0. The licensee is prohibited from knowingly receiving any solid waste not authorized in this section.
<b>3.2</b>	<b>General conditions on activities</b>	The licensee is authorized to perform at the facility only those waste-related activities that are described in Section 3.0.
<b>3.3</b>	<b>Acceptance of source-separated recyclable materials</b>	The licensee is authorized to accept source-separated recyclable materials and materials separated for reuse for the purpose of sorting, classifying, consolidating, baling, temporary storage, transfer and other similar functions related to preparing these materials for reuse or recycling.
<b>3.4</b>	<b>Acceptance and management of certain special waste</b>	1. The licensee is authorized to accept certain types of special waste, including but not limited to batteries and lightbulbs, generated by residential customers, for the purpose of consolidating, transfer and other similar functions related to preparing these materials for reuse or recycling.



		2. The licensee must manage all special waste that it receives in accordance with its Special Waste Management Plan as approved by the Oregon Department of Environmental Quality (DEQ).
3.5	<b>Acceptance and management of electronic devices</b>	The licensee is authorized to accept source-separated electronic devices for the purpose of sorting, classifying, consolidating, baling, temporary storage, transfer and other similar functions related to preparing these materials for reuse and recycling.
3.6	<b>Material processing required</b>	<ol style="list-style-type: none"> <li>1. The license may process (e.g. sort) the source-separated recyclable materials received at the facility.</li> <li>2. The license must design and operate the facility to process materials in a timely manner and to protect the quality of source-separated recyclable material that has not yet undergone material processing.</li> <li>3. The licensee must protect source-separated recyclables from contamination from other solid wastes and not allow source-separated recyclables to degrade due to exposure to elements including sun, wind or rain.</li> </ol>
3.7	<b>Facility capacity</b>	The licensee must maintain sufficient capacity to adequately accept, process, store, and otherwise manage all of the materials that are received and generated at the facility.

<b>4.0</b>	<b>LIMITATIONS AND PROHIBITIONS</b>	
4.1	<b>Prohibited waste</b>	The licensee must not knowingly receive, process, or store any solid waste not authorized in this license. The licensee must not knowingly accept or retain any material amounts of the following types of wastes: non-putrescible or special waste other than that specifically allowed in Section 3.0; putrescible waste; yard debris; creosote-treated or painted wood; materials contaminated with or containing asbestos; lead acid batteries; liquid waste for disposal; vehicles; infectious, biological or pathological waste; radioactive waste; hazardous waste; explosives; or any waste prohibited by DEQ.
4.2	<b>Prohibition on mixing</b>	The licensee must not mix source-separated recyclable materials with any waste unless such mixing is described in an operating plan and approved in writing by Metro.
4.3	<b>No disposal of recyclable materials</b>	The licensee must not transport source-separated recyclable materials to a disposal site, including landfills and incineration facilities, without written permission from Metro and DEQ.
4.4	<b>Limits not exclusive</b>	This license does not limit, restrict, curtail or abrogate any limitation or prohibition contained elsewhere in this license document, in Metro Code or in any federal, state, regional or local government law, rule, regulation, ordinance, order or permit.



5.0	<b>OPERATING CONDITIONS</b>	
5.1	<b>General performance standards</b>	<p>The licensee must operate in a manner that meets the following general performance standards:</p> <ol style="list-style-type: none"> <li>1. Environment. The licensee must design and operate the facility to avoid undue threats to the environment including, but not limited to, stormwater or groundwater contamination, air pollution and improper acceptance and management of hazardous waste, asbestos and other prohibited wastes.</li> <li>2. Health and safety. The licensee must design and operate the facility to avoid conditions that may degrade public health and safety including, but not limited to, fires, vectors, pathogens and airborne debris.</li> <li>3. Nuisances. The licensee must design and operate the facility to avoid nuisance conditions including, but not limited to, litter, dust, odors and noise.</li> </ol>
5.2	<b>Qualified operator</b>	<ol style="list-style-type: none"> <li>1. The licensee must, during all hours of operation, provide an operating staff employed by the facility that is qualified and competent to carry out the functions required by this license and to otherwise ensure compliance with Metro Code Chapter 5.01.</li> <li>2. Facility personnel, as relevant to their job duties and responsibilities, must be familiar with the relevant provisions of this license and the relevant procedures contained within the facility's operating plan.</li> <li>3. A qualified operator must be an employee of the facility with training and authority to reject prohibited waste that is discovered during load checks and to properly manage prohibited waste that is unknowingly received.</li> </ol>
5.3	<b>Fire prevention</b>	<p>The licensee must provide fire prevention, protection and control measures including, but not limited to:</p> <ol style="list-style-type: none"> <li>1. Adequate water supply for fire suppression; and</li> <li>2. The isolation of potential heat sources and/or flammables from the processing and storage areas.</li> </ol>
5.4	<b>Adequate vehicle accommodation</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Provide access roads of sufficient capacity to adequately accommodate all on-site vehicular traffic. The licensee must maintain access roads to allow the orderly egress and ingress of vehicular traffic when the facility is in operation, including during inclement weather;</li> <li>2. Take reasonable steps to notify and remind persons delivering solid waste to the facility that vehicles must not park or queue on public streets or roads except under emergency conditions or as provided by</li> </ol>



		<p>local traffic ordinances; and</p> <p>3. Provide adequate off-street parking and queuing for vehicles, including adequate space for on-site covering and uncovering of loads.</p>
5.5	<b>Management of source-separated recyclable materials</b>	<p>1. The licensee must receive and reload source-separated recyclables on an impervious surface (e.g. asphalt or concrete).</p> <p>2. The licensee must move materials inside a building that is enclosed on at least three sides within 12 hours of receipt or by end of the business day except as otherwise described in Section 5.6.</p> <p>3. The licensee must store source-separated recyclable materials on an impervious surface within a covered building that is enclosed on at least three sides except as otherwise described in Section 5.6.</p>
5.6	<b>Outdoor storage of source-separated recyclable materials</b>	<p>The licensee may store source-separated recyclable materials and recovered recyclable materials outside of a roofed building if the storage complies with local and state fire codes and meets at least one of the following conditions:</p> <p>1. The material is stored within an enclosed shipping container, enclosed vehicle, securely covered drop box (roll off container), compactor, or other similar secure portable storage container;</p> <p>2. The material is stored on an impervious surface and securely covered in order to be protected from wind and precipitation; or</p> <p>3. The material is stored in a manner that prevents material degradation, vectors, litter, odors, fires, or other conditions that may threaten the environment or quality of the material. Metro may require the licensee to modify outdoor storage practices to avoid nuisances, or other health, safety, or environmental problems.</p>
5.7	<b>Management of non-recyclable waste received</b>	<p>The licensee must:</p> <p>1. Store all non-recyclable waste unknowingly received on an impervious surface, for example asphalt or concrete, inside a roofed building that is enclosed on at least three sides, or alternatively, inside watertight covered containers or within covered transport trailers; and</p> <p>2. Keep all non-recyclable waste unknowingly received physically separated from and not mixed or commingled with source-separated recyclable materials.</p>
5.8	<b>Storage and exterior stockpiles</b>	<p>The licensee must:</p> <p>1. Manage, contain, and remove, at sufficient frequency, stored materials and solid wastes to avoid creating nuisance conditions, vector or bird attraction or harborage, or safety hazards;</p> <p>2. Maintain storage areas in an orderly manner and keep the areas free of litter;</p>



		<ol style="list-style-type: none"> <li>3. Position exterior stockpiles within footprints identified on the facility site plan or operating plan; and</li> <li>4. Not stockpile recovered or source-separated non-putrescible materials for longer than 180 days (6 months).</li> </ol>
<b>5.9</b>	<b>Managing prohibited wastes</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Reject prohibited waste that is discovered upon receipt.</li> <li>2. Maintain a load-check program to prevent the acceptance of prohibited waste. At minimum the licensee must: <ol style="list-style-type: none"> <li>(a) Provide a qualified operator to perform visible inspection of each load received. The qualified operator must reject prohibited waste discovered during the visual inspection.</li> <li>(b) Provide a secure or isolated containment area for the storage of any prohibited wastes that are unknowingly received. Containment areas must be covered and enclosed to prevent leaking and contamination of authorized materials.</li> <li>(c) Maintain records of the training of facility personnel in the recognition, proper handling and disposition of prohibited waste and make these records available to Metro upon request.</li> </ol> </li> <li>3. Remove all prohibited or unauthorized wastes upon discovery when unknowingly received or manage the waste in accordance with DEQ requirements and procedures established in the operating plan. All such wastes the licensee unknowing receives must be removed from the site and transported to an appropriate destination within 90 days of receipt, unless required to be removed earlier by Metro, DEQ or a local government.</li> </ol>
<b>5.10</b>	<b>Dust, airborne debris and litter</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Operate the facility in a manner that controls and minimizes the generation and migration of dust, airborne debris and litter beyond property boundaries;</li> <li>2. Take reasonable steps, including signage, to notify and remind persons delivering solid waste to the facility that all loads must be suitably secured to prevent any material from blowing off the load during transit;</li> <li>3. Maintain and operate all vehicles and devices transferring or transporting solid waste from the facility to prevent leaking, spilling or blowing of solid waste on-site or while in transit;</li> <li>4. Maintain and operate all access roads and receiving, processing, storage and reload areas in such a manner as to control and minimize dust and debris generated on-site and prevent such dust and debris from blowing or settling off-site;</li> <li>5. Keep all areas within the site and all vehicle access roads within ¼ mile of the site free of litter and debris generated directly or</li> </ol>





		<p>indirectly as a result of the facility's operation;</p> <ol style="list-style-type: none"> <li>6. Maintain on-site facility access roads to control and minimize dust and the tracking of mud, gravel or other debris off-site; and</li> <li>7. Provide access to the facility for the purpose of uncovered load enforcement. During all times that solid waste is being accepted, authorized representatives of Metro, including law enforcement personnel on contract to Metro, must be permitted access to the premises of the facility for the purpose of making contact with individuals they have observed transporting uncovered loads of solid waste on a public road right-of-way in violation of Metro Code Chapter 5.09.</li> </ol>
<b>5.11</b>	<b>Odor</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Operate the facility in a manner that controls and minimizes the generation of odors that are detectable off-site;</li> <li>2. Establish and follow procedures in the operating plan for minimizing odor at the facility; and</li> <li>3. Follow its odor control procedures as described in its operating plan and immediately take other corrective actions as necessary to comply with the requirements of this license.</li> </ol>
<b>5.12</b>	<b>Vectors (e.g. birds, rodents, insects)</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Operate the facility in a manner that is not conducive to the harboring of rodents, birds, insects or other vectors capable of transmitting, directly or indirectly, infectious diseases to humans or from one person or animal to another; and</li> <li>2. Implement vector control measures if vectors are present or detected at the facility.</li> </ol>
<b>5.13</b>	<b>Noise</b>	<p>The licensee must operate the facility in a manner that:</p> <ol style="list-style-type: none"> <li>1. Controls and minimizes any noise sufficient to cause adverse off-site impacts; and</li> <li>2. Meets applicable regulatory standards and land-use regulations.</li> </ol>
<b>5.14</b>	<b>Water contaminated by solid waste and solid waste leachate</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Operate and maintain the facility to prevent contact of solid wastes with storm water runoff and precipitation; and</li> <li>2. Dispose of or treat water contaminated by solid waste generated onsite in a manner complying with local, state, and federal laws and regulations.</li> </ol>
<b>5.15</b>	<b>Access control</b>	<p>The licensee must control access to the facility as necessary to prevent unauthorized entry and dumping.</p>



5.16	<b>Signage</b>	<p>The licensee must post signs at all public entrances to the facility. The signs must comply with local government signage regulations. These signs must be easily and readily visible and legible from off-site during all hours and must contain at least the following information:</p> <ol style="list-style-type: none"> <li>1. Name of the facility;</li> <li>2. Address of the facility;</li> <li>3. Emergency telephone number for the facility; and</li> <li>4. Metro's name and telephone number (503) 234-3000.</li> </ol>
5.17	<b>Complaints</b>	<p>The licensee must respond to all complaints as described in the operating plan.</p>
5.18	<b>Access to license document</b>	<p>The licensee must maintain a copy of this license on the facility's premises in a location where facility personnel and Metro representatives have ready access to it.</p>
5.19	<b>Employment standard</b>	<p>The licensee must:</p> <ol style="list-style-type: none"> <li>1. Comply with Oregon's "ban the box" law (ORS 659A.360) which makes it unlawful for an employer to inquire about criminal convictions before the interview stage of hiring; and</li> <li>2. Maintain a copy of the facility's employment application on the facility premises and in a location where facility personnel and Metro representatives have ready access to it.</li> </ol>

<b>6.0</b>	<b>OPERATING PLAN</b>	
6.1	<b>Plan compliance</b>	<p>The licensee must operate the facility in accordance with an operating plan approved in writing by Metro. The operating plan must include sufficient detail to demonstrate that the facility will be operated in compliance with this license. The licensee may amend or revise the operating plan from time to time, subject to written approval by Metro.</p>
6.2	<b>Plan maintenance</b>	<ol style="list-style-type: none"> <li>1. The licensee must submit an updated operating play to Metro as provided in section 6 of this license by July 22, 2022.</li> <li>2. The licensee must revise the operating plan as necessary to keep it current with facility conditions, procedures and requirements. The licensee must submit revisions of the operating plan to Metro for written approval prior to implementation.</li> </ol>
6.3	<b>Access to operating plan</b>	<p>The licensee must maintain a copy of the operating plan on the facility premises in a location where facility personnel and Metro representatives have ready access to it.</p>



6.4	<b>Procedures for inspecting loads</b>	<p>The operating plan must include:</p> <ol style="list-style-type: none"> <li>1. Procedures for inspecting incoming loads for the presence of prohibited or unauthorized wastes; and</li> <li>2. A set of objective criteria for accepting and rejecting loads.</li> </ol>
6.5	<b>Procedures for processing and storage of loads</b>	<p>The operating plan must include procedures for:</p> <ol style="list-style-type: none"> <li>1. Processing authorized solid wastes;</li> <li>2. Reloading and transporting authorized solid wastes;</li> <li>3. Managing stockpiles to ensure that they remain within the authorized limits;</li> <li>4. Storing authorized solid wastes; and</li> <li>5. Minimizing storage times and avoiding delay in processing of authorized solid wastes.</li> </ol>
6.6	<b>Procedures for managing prohibited wastes</b>	<p>The operating plan must include procedures for:</p> <ol style="list-style-type: none"> <li>1. Managing, reloading and transporting to appropriate facilities or disposal sites any prohibited or unauthorized wastes if they are discovered at the facility; and</li> <li>2. Notifying generators not to place hazardous wastes or other prohibited wastes in drop boxes or other collection containers destined for the facility.</li> </ol>
6.7	<b>Procedures for controlling and minimizing off-site impacts</b>	<p>The operating plan must include procedures for controlling and minimizing off-site impacts generated at the facility from being detected off the premises of the facility, including, but not limited to, odor, dust, litter, noise and vectors. The operating plan must include procedures that will be used to monitor and manage:</p> <ol style="list-style-type: none"> <li>1. Odors of any derivation including odorous loads delivered to the facility;</li> <li>2. Dust and litter of any derivation;</li> <li>3. Noise from facility operations and associated activities; and</li> <li>4. Vectors.</li> </ol>
6.8	<b>Procedures for emergencies</b>	<p>The operating plan must include procedures that the licensee will follow in case of fire or other emergency.</p>
6.9	<b>Procedures for complaints</b>	<p>The operating plan must include procedures for managing complaints. If the facility receives a complaint, the licensee must:</p> <ol style="list-style-type: none"> <li>1. Respond within one business day or sooner as circumstances may require.</li> <li>2. Record the following information for every complaint it receives: <ol style="list-style-type: none"> <li>(a) Type of complaint (for example odor, dust, noise, litter, etc.);</li> </ol> </li> </ol>



		<p>(b) Date the complaint was received;</p> <p>(c) Name, address and telephone number of the complainant; and</p> <p>(d) Description of the actions that the licensee took in response to the complaint, whether successful or unsuccessful.</p> <p>3. Make the records required by this section available to Metro upon request. The licensee must retain each complaint record for a period of not less than one year.</p>
<b>6.10</b>	<b>Closure protocol</b>	<p>1. The licensee must establish protocol for closure and restoration of the site in the event of a cession of operations as provided in Metro Code Chapter 5.01.</p> <p>2. The plan must include protocol for:</p> <p>(a) Short-term closure (duration of time that is more than seven consecutive days but less than 30 consecutive days in length); and</p> <p>(b) Long-term closure (duration of time that is 30 consecutive days or more in length).</p> <p>3. The licensee must notify Metro within one business day of a short-term or long-term closure of the facility.</p>

<b>7.0</b>	<b>FEES AND RATES</b>	
<b>7.1</b>	<b>Annual fee</b>	The licensee must pay an annual license fee, as established in Metro Code Chapter 5.01. Metro reserves the right to change the license fee at any time by action of the Metro Council.
<b>7.2</b>	<b>Rates not regulated</b>	Metro does not regulate the rates charged at the facility.
<b>7.3</b>	<b>Regional system fee and excise tax</b>	The licensee is liable for payment of the Metro regional system fee, as provided in Metro Code Chapter 5.02, and the Metro excise tax, as provided in Metro Code Chapter 7.01, on all solid wastes transported to a disposal site.

<b>8.0</b>	<b>RECORD KEEPING AND REPORTING</b>	
<b>8.1</b>	<b>Record keeping requirements</b>	<p>For all solid waste the licensee is authorized to receive under Section 3.0, the licensee must keep and maintain accurate records of:</p> <p>1. The amount of those materials that the licensee receives, reloads, recovers for delivery to reuse or recycling markets, and disposes; and</p> <p>2. The destination of outbound materials.</p>



8.2	<b>Reporting requirements</b>	The licensee must report to Metro the records required under Section 8.1 no later than fifteen days following the end of each month in the form and format prescribed by Metro. An authorized representative of the licensee must certify that the report is accurate.
8.3	<b>Account number listing</b>	Within five business days of Metro's request, the licensee must provide Metro with a listing that cross-references the customer accounts for the material received at the facility with the name of the jurisdiction where it was collected.
8.4	<b>Transactions based on scale weights</b>	The licensee must record the weight of each inbound and outbound transaction electronically based on actual and accurate scale weights or other method approved in writing by Metro.
8.5	<b>DEQ submittals</b>	The licensee must provide Metro with copies of all correspondence, exhibits or documents submitted to DEQ relating to the terms or conditions of DEQ permits or this license within five business days of providing such information to DEQ.
8.6	<b>Copies of enforcement actions provided to Metro</b>	The licensee must provide Metro with a copy of any notice of violation or non-compliance, citation or any other similar enforcement action issued to the licensee by any federal, state or local government (other than Metro) related to the operation of the facility within five business days of receipt.

<b>9.0</b>	<b>INSURANCE REQUIREMENTS</b>	
<b>9.1</b>	<b>General liability</b>	The licensee must carry the most recently approved Insurance Services Office (ISO) Commercial General Liability policy, or its equivalent, written on an occurrence basis, with limits not less than \$1,000,000 per occurrence. The policy must include coverage for bodily injury, property damage, personal injury, death, contractual liability, premises and products/completed operations. The licensee's coverage will be primary as respects Metro.
<b>9.2</b>	<b>Automobile</b>	The licensee must carry automobile insurance with coverage for bodily injury and property damage with limits not less than a minimum of \$1,000,000 per accident or combined single limit.
<b>9.3</b>	<b>Additional insureds</b>	Metro, its elected officials, departments, employees, volunteers and agents must be named as ADDITIONAL INSUREDS on the Commercial General Liability policy. The licensee must include the additional insured endorsement along with the certificate of insurance.
<b>9.4</b>	<b>Workers' compensation insurance</b>	<ol style="list-style-type: none"> <li>1. The licensee, its subcontractors, if any, and all employers working under this license, are subject employers under the Oregon Workers' Compensation Law and must comply with ORS 656.017, which requires them to provide workers' compensation coverage for all their subject workers.</li> <li>2. The licensee must provide Metro with certification of workers' compensation insurance including employer's liability. If the licensee has no employees and will perform the work without the assistance of others, a certificate to that effect may be attached in lieu of the certificate showing current workers' compensation insurance.</li> </ol>

<b>10.0</b>	<b>ENFORCEMENT</b>	
<b>10.1</b>	<b>Authority vested in Metro</b>	The power and right to regulate, in the public interest, the exercise of the privileges granted by this license is at all times vested in Metro. Metro reserves the right to establish or amend rules, regulations or standards regarding matters within Metro's authority, and enforce all such requirements against the licensee.
<b>10.2</b>	<b>No enforcement limitations</b>	This license may not be construed to and does not limit, restrict, curtail or abrogate any enforcement provision contained in Metro Code or administrative rules adopted pursuant to Metro Code Chapter 5.01, nor does this license limit or preclude Metro from adopting ordinances that regulate the health, safety or welfare of any person or persons within the Metro jurisdictional boundary, notwithstanding any incidental impact that such ordinances may have upon the terms of this license or the licensee's operation of the facility.
<b>10.3</b>	<b>Penalties</b>	Each violation of a license condition shall be punishable by penalties as established in Metro Code Chapter 5.01. Each day a violation continues constitutes a separate violation.

<b>11.0</b>	<b>AMENDMENT, SUSPENSION, REVOCATION AND TERMINATION</b>	
<b>11.1</b>	<b>Amendment, suspension or revocation by Metro</b>	<p>Metro may, at any time before the expiration date, amend, suspend or revoke this license in whole or in part, in accordance with Metro Code Chapter 5.01, for reasons including but not limited to:</p> <ol style="list-style-type: none"> <li>1. Violation of the terms or conditions of this license, Metro Code or any applicable statute, rule, or standard;</li> <li>2. Changes in local, regional, state, or federal laws or regulations that should be specifically incorporated into this license, such as Metro actions to implement new requirements from the 2030 Regional Waste Plan;</li> <li>3. Failure to disclose fully all relevant facts;</li> <li>4. A significant release into the environment from the facility;</li> <li>5. A significant change in the character of solid waste received or in the operation of the facility;</li> <li>6. Any change in ownership or control;</li> <li>7. A request from the local government stemming from impacts resulting from facility operations;</li> <li>8. A change of authorization request received from the licensee; and</li> <li>9. Compliance history of the licensee.</li> </ol>



<b>11.2</b>	<b>Termination</b>	Metro may, at any time before the expiration date, terminate this license upon request of the licensee or in the event of a long term closure of the facility as described in Section 6.10.

<b>12.0</b>	<b>GENERAL OBLIGATIONS</b>	
<b>12.1</b>	<b>Compliance with law</b>	The licensee must fully comply with all applicable local, regional, state and federal laws, rules, regulations, ordinances, orders and permits pertaining in any manner to this license, including all applicable Metro Code provisions and administrative rules, whether or not those provisions have been specifically mentioned or cited in this license. All conditions imposed on the operation of the facility by federal, state, regional or local governments or agencies having jurisdiction over the facility are deemed part of this license as if specifically set forth in this license. These conditions and permits include those cited within or attached as exhibits to the license document, any existing at the time the license is issued but not cited or attached, and any issued or amended during the term of the license.
<b>12.2</b>	<b>Transport waste to appropriate destinations</b>	The licensee must ensure that solid waste transported from the facility goes to the appropriate destinations under Metro Code Chapters 5.01 and 5.05, and under applicable local, state and federal laws, rules, regulations, ordinances, orders and permits.
<b>12.3</b>	<b>Right of inspection and audit</b>	<ol style="list-style-type: none"> <li>1. The licensee must allow Metro's authorized representatives to access the facility and premises at any time during business hours, with or without advanced notice. For non-business hours, the licensee must allow access to Metro's authorized representatives upon receiving advanced notice of not less than 24 hours.</li> <li>2. Authorized representatives of Metro may take photographs, collect samples of materials and perform such inspection or audit as Metro deems appropriate.</li> <li>3. Metro inspection reports, including site photographs, are public records subject to disclosure under Oregon Public Records Law. Subject to the applicable confidentiality provisions in Section 12.4, Metro's right to inspect includes the right to review all information from which all required reports are derived including all books, maps, plans, income tax returns, financial statements, contracts and other similar written materials of the licensee that are directly related to the facility's operation and its rates.</li> <li>4. The licensee must permit access to the facility premises to authorized representatives of Metro, including personnel on contract to Metro, to perform research at all times during business hours, with or without notice. <b>12.4</b>	<b>Confidential information</b>	<ol style="list-style-type: none"> <li>1. The licensee may identify as confidential any reports, books, records, maps, plans, income tax returns, financial statements, contracts and other similar written materials of the licensee that are directly related to the operation of the facility and that are submitted to or reviewed by Metro. The licensee must prominently mark any information that it claims confidential with the mark "CONFIDENTIAL" prior to submittal to or review by Metro. Metro will treat as confidential any information so marked and will make a good faith effort not to disclose the information unless Metro's refusal to disclose the information would be contrary to applicable Oregon law, including, without limitation, ORS Chapter 192.</li> <li>2. If Metro receives a public records request seeking disclosure of information identified as confidential by the licensee, Metro will provide the licensee with a courtesy notice of that request within five days of receipt of the request.</li> <li>3. This Section 12.0 does not limit the use of any information submitted to or reviewed by Metro for regulatory purposes or in any enforcement proceeding.</li> <li>4.
