This packet contains an application for a Metro Solid Waste Facility License. You may also want to review the relevant sections of Metro Code. Metro Code Chapter 5.01 identifies which solid waste facilities and activities require a Metro license. You can access the Metro Code via the Metro website at www.oregonmetro.gov/metro-code.

Metro staff will generally review an application for completeness within 15 business days of receipt and notify the applicant whether their application is deemed to be complete. If an application is incomplete, Metro will notify the applicant as to what additional information is required.

Application for a new Solid Waste Facility License

An applicant seeking a new Metro Solid Waste Facility License must first attend a pre-application conference before submitting an application. The purpose of the pre-application conference is for Metro to obtain a description of the proposed solid waste facility and provide the applicant with information regarding the applicable requirements for the proposed operation. The conference also provides the applicant with an opportunity to discuss the application process and to identify any potential issues specific to its proposal. An applicant should prepare for the pre-application conference by reviewing application forms and drafting responses before the conference. To schedule a pre-application conference, contact Joanna Dyer, Metro's Solid Waste Authorization Coordinator at 971-401-0976 or via email at SWICC@oregonmetro.gov.

After completing the pre-application conference, an applicant seeking a new license must submit to Metro a completed *Solid Waste Facility License Application* form and provide all additional information as required. Metro will generally approve or deny a new license within 180 days after Metro deems the application to be complete. The fee for filing a license application is \$300. See Metro Code Chapter 5.01 for more information regarding the issuance of a license.

Renewal of an Existing License

An applicant seeking to renew an existing license without substantive changes to the current authorization must submit a completed *Solid Waste Facility License Application* form and provide all additional information as required, unless Metro staff directs otherwise. License renewal applications must be submitted not less than 120 days before the current license expires. If a licensee fails to submit a timely renewal application, the licensee's authority to operate may lapse. Additionally, Metro is not obligated to renew a license earlier than the expiration date of the existing license even if the licensee files a renewal application more than 120 days before the existing license expires. The fee for filing a license renewal application is \$300. See Metro Code Chapter 5.01 for more information regarding the renewal of licenses.

Change of Authorization to an Existing License

An applicant seeking a change of authorization for an existing license (other than renewal) must submit to Metro a completed *Solid Waste Facility License Application* form and provide all additional information as required unless Metro staff directs otherwise. The applicant cannot implement the requested change of authorization until Metro approves it in writing. The fee for filing a change of authorization application is \$100. See Metro Code Chapter 5.01 for more information regarding changes of authorization for licenses. Metro may require the applicant to apply for a new license if there is a significant change in the types of solid waste accepted or activities performed at a facility.

Transfer of Ownership or Control of an Existing License

An applicant seeking to transfer ownership or control of an existing license must submit to Metro a completed *Solid Waste Facility License Application* form and provide all additional information as required, unless Metro staff directs otherwise. See Metro Code Chapter 5.01 for more information regarding requirements for the transfer of ownership for a licensed facility.

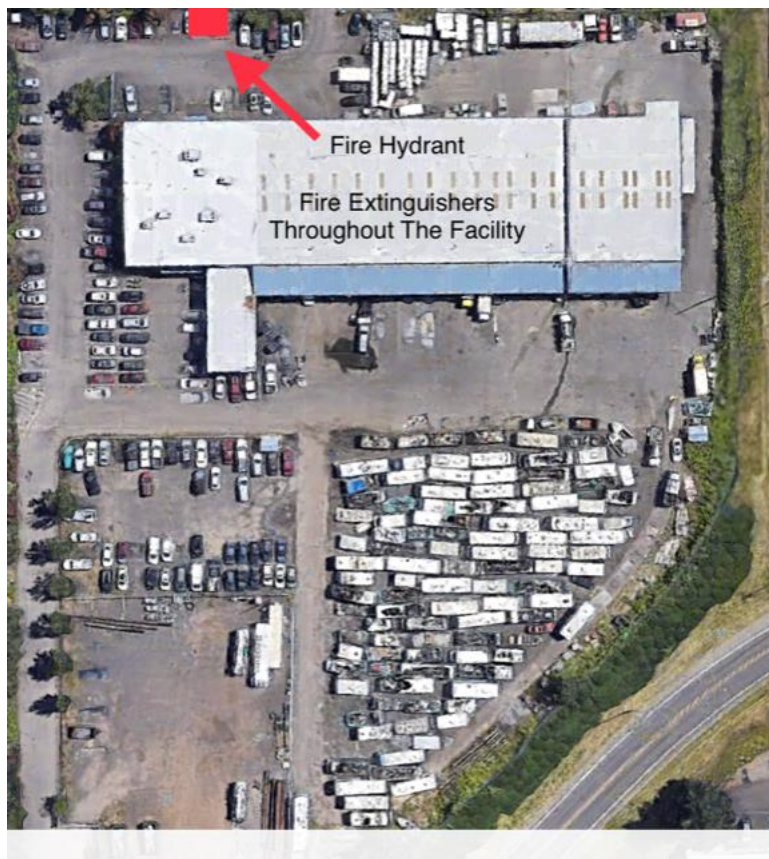

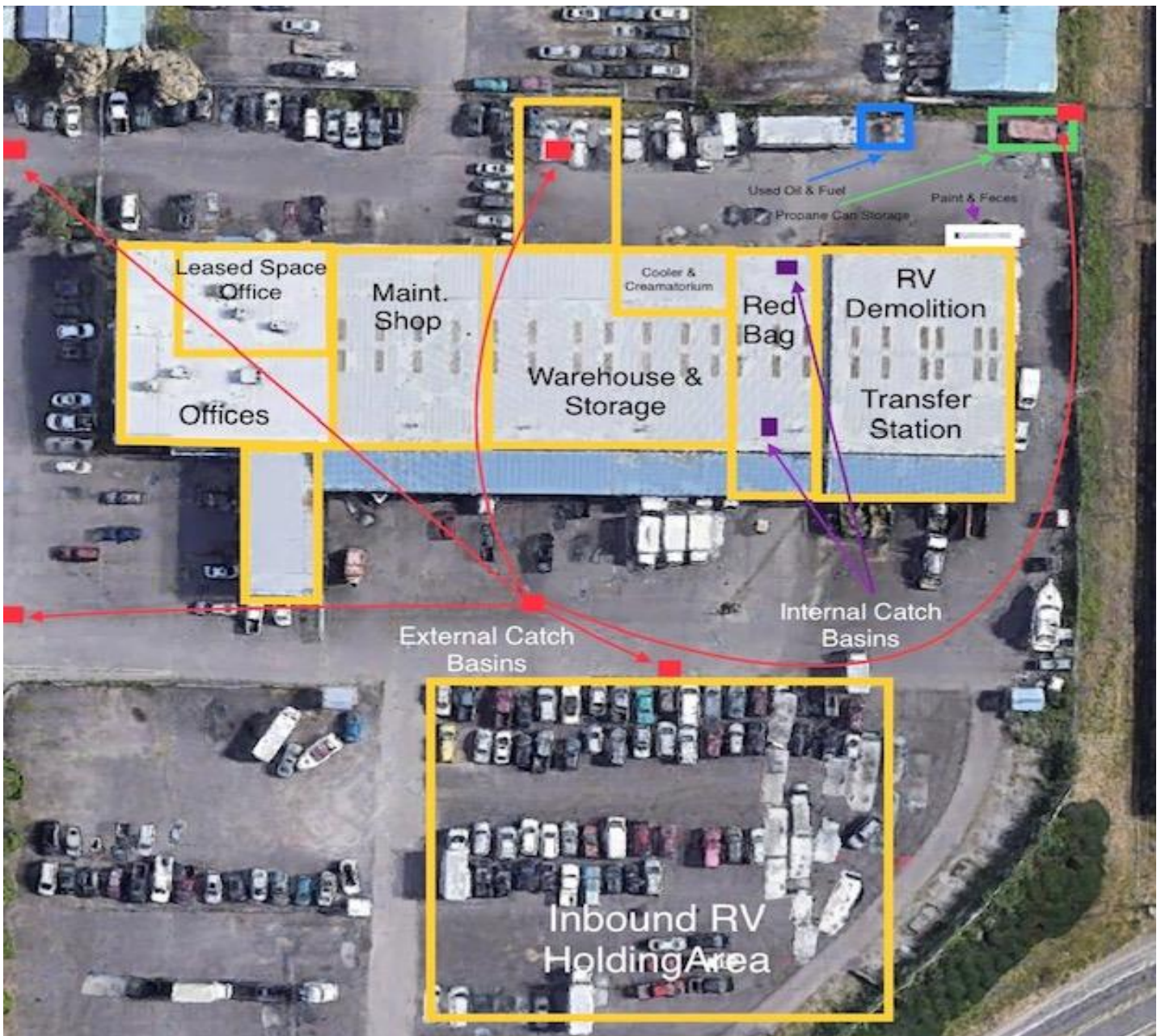

2. Purpose of the Operations Plan

The purpose of the operations plan is to outline the procedure for accepting and processing vehicles that are to be dismantled and disposed of at the Synergy Environmental Disposal Facility; describe the process for disposal and/or recycling of medical waste; describe the process for recycling plastic medical waste and other polyolefins.

3.

Operational Overview

The Synergy Environmental Disposal Facility is not open to the public. Only by appointment can a private party bring in a vehicle. Typically tow trucks contracted by a government agency bring in vehicles.

The Synergy Environmental Disposal Facility is in the industrial complex owned by Terry Emmert. The business is owned and operated by Lance Hamel. This facility receives vehicles from the surrounding areas from private citizens, companies, and various government agencies for disposal. Rapid Response Bio Clean is a Licensed Dismantler (#WR3589 Attached) Vehicles are brought into a secured yard and stored prior to disposal. No processing of any kind takes place in the secured yard.

All Vehicles/Vessels have an asbestos survey conducted to determine if asbestos exists. This is performed by PDX Enviro, an accredited asbestos inspector. If a vehicle is determined to contain asbestos, it is moved to a designated holding area, pending asbestos abatement by a DEQ licensed asbestos abatement contractor.

All vehicles which test negative for asbestos are brought into the center of an enclosed building where fluids are drained (on a concrete floor with no drain) and set aside for proper disposal. The interior of the vehicle is inspected for types of waste that need to be separated (such as paint, sharps, batteries, gas cans, and propane tanks). These items are removed, placed, or stored in an approved container or location. Once these materials, if any, are removed and stored, a small track hoe with a hydraulic thumb attachment tears the roof and walls of the chassis. The walls, roof, and floor are broken up by the excavator and placed in a drop box to be removed and disposed of by Sunset Garbage or Rapid Response. The chassis is then moved to the south side of the building where the wheels and tires are removed and placed in a flatbed truck for transport to Tire Disposal Company in Molalla, OR (Tire Hauling Permit # 1724 Attached) The frame is then cut into manageable size pieces with a plasma cutter. The frame, transmission, axles, engine, and other metal parts are placed into a scrap bin that is transported by Rivergate Scrap (or one of their affiliates) for recycling.

Other hazardous materials: If received, any airbag will be removed and placed in a sealed 55-gallon drum to be recycled by Clean Harbors. Oil filters are drained, and the filters are sent for scrap metal recycling. All petroleum and other hazardous liquids (anti-freeze, etc.) are separated and stored inside the facility until 50 gallons have accumulated. They are then moved outside to a secure Conex box. Fluids are picked up monthly (or as needed) for recycling by Orrco Oil Re-Refining Company. When possible, propane gas is burned for heat until it is empty, valves are removed, and tanks are recycled with scrap metal. Tanks that cannot be used are picked up and recycled by Cylinder Depot. Batteries are stacked on a pallet and picked up by RS Davis for recycling, biowaste from gray and black water tanks is pumped into 275-gallon IBC containers and transferred by Synergy Environmental to Clean Water Services for disposal weekly. Buckets of mixed urine and sewage are brought back to the facility and dumped over a strainer into a

275-gallon IBC tank. The tank is suctioned out by our sewage truck and transported weekly to Clean Water Services for disposal.

Refrigerant is removed on site by Rapid Recovery HVAC contractor.

Medical waste (sharps/syringes/needles) generated in Multnomah County are collected several times per week and taken to the Johnson Creek Facility. This waste is all contained in plastic tubs and separated by the content of each container. Some waste is mailed to our location through an approved program with The United States Postal Service. Non plastic material (i.e. contaminated linens, contaminated cardboard, medications, medical instruments, broken contaminated glass, epi pens, lab samples of bodily fluids and solids, acupuncture needles, diapers, etc.), is loaded into a box truck and taken to Trilogy Medwaste Facility at 10400 N Burgard Way. Portland, Oregon 97203. On a weekly basis. Plastic waste is treated in an autoclave machine built by Red Bag Solutions Model SSM-150. This machine has been approved as an alternative treatment for medical waste by the Oregon Health Authority. Heat, water, and pressure, as well as a large grinding blade treat the material and once processed, it becomes completely sterile. Only water is used in this process and that is the only thing discharged by the process. This plastic material is then floated in a tank of water that allows the polyolefins (the premium material) to float and the rest of the material to sink. Several magnets in the float tank are used to remove any remaining metal. The remaining metal needle pieces are sent to RS Davis in a rigid, lidded, plastic container for recycling. The material that sinks (about 10% of the processed material) is then discarded as solid waste. The remaining plastic can be recycled in several ways. Currently, material is sold to Cyclix Recycling in Tigard, Oregon. My understanding is that they transport the product to Baytown, Texas. We are always looking for other companies who will buy the product.

Empty portable toilets are stored in the outdoor storage yard before and after they are deployed to different areas in Multnomah and Clackamas counties. We currently have 5. DEQ licensed sewage transfer trucks (Permit #39171 Attached) with approximately 150 portable toilets and sinks in the field. These are all serviced on a regular basis and all waste is transported to Clean Water Services in Tigard and disposed of under their guidelines. Trucks are stored at the Johnson Creek Facility and are filled with water and serviced there as well.

A cremation machine and walk-in cooler are being installed under a different DEQ air permit. Synergy First call Inc, a separate company owned by Lance Hamel 50% and Samantha Hamel 50% and will operate at the Johnson creek Facility under DEQ (Permit # AQGP-012 Attached). Synergy First Call will transport deceased bodies from funeral homes, hospitals, and care facilities to the county medical examiner or to our facility to be stored at 36 degrees in our walk-in cooler. Bodies will then be transported to another facility or cremated with the remains to be given to the family. No ashes or human remains will be disposed of on site.

a. Hours of Operation

We operate typically Monday through Friday from 7:30 am to 4:00pm. At times we operate on Saturday and Sunday, and (if the workload is required or we are dispatched) will work 24 hours per day.

b. Access Control

The facility is fully fenced to control access. The gate is open during operation times only and the public is not permitted to enter at any time without permission.

c. Reporting Requirements

For reporting requirements, please refer to our DEQ Solid Waste Disposal Site Permit, Oregon Funeral Directors Association, DEQ Air Permit, or DEQ Sewage Hauler Permit.

d. Litter Prevention and Control

- i. Litter is picked up within the yard several times a day. The fence keeps any solid debris from leaving our yard.
- ii. We also own and operate a sweeper truck on a as needed basis.

e. Vector Prevention and Control

Since there is not much food waste at our facility (only employee generated garbage), vector control has not really been necessary. We do have bait stations placed against walls as a preventative measure.

f. Dust/Noise/Odor Prevention and Control

All our operations take place inside an enclosed building so dust and noise are not typically a problem. Odor is minimal and does not pose a problem.

g. Storm and Sanitary Disposal

No work is done outside of the building. There are two catch basins inside the building. (Catch basins are identified on the site map and detailed in Catch Basin attachment.) These two catch basins inside the facility are capped so there is no discharge. The restrooms are all connected to City Sewer.

h. Opportunity to Recycle

The only recycling opportunity is for scrap metal. Recovered scrap metal is recovered and delivered to or picked up by Rivergate Scrap or one of its affiliates (RS Davis, PNW Metals).

i. Truck Washing Facility

There is no truck washing facility onsite. All truck washing takes place offsite.

j. Leachate Management

There is no leachate collection system in place as all activities are done within the building with no draining. Any fluids leaked out are cleaned up immediately within the facility.

k. Stormwater Treatment and Discharge

Stormwater is discharged into several catch basins throughout the property. All catch basins have bio-bags surrounding them and are changed out as needed. **(See site map for drain locations)**

l. Facility Operation Equipment

Synergy Environmental Disposal Facility uses a track hoe to dismantle the RV's, forklifts, street sweeper, gas powered cremation machine and medical waste processor.

m. Complaint Response and Tracking

All complaints are reported to the Site Manager and responded to accordingly. All complaints and concerns are stored electronically in a digital file by the Site Manager. A record of the complaint will include the name and contact information of complainant (when possible), date complaint was received, date and description of initial facility response and any follow-up response.

4. Waste Handling Procedures

a. Waste Streams (RV's, Tires, Grey/Black Water, Gas, Oil, Propane Tanks)

We receive waste mainly from the destruction of vehicles and their contents. This can include but is not limited to metal, glass, fabric, petroleum products, tires, batteries, biohazards, infectious waste, and asbestos containing products. (See SWMP section for details.)

b. Waste Receiving

Vehicles are towed in by different cities, counties, governmental agencies, to be dismantled in the enclosed facility.

c. Load Inspection

All vehicles, boats, and RV's (travel trailers, motor homes) towed to our facility are logged in and staged for Asbestos Testing and Abatement if needed.

d. Load Rejection Procedures

There are no Rejection Procedures as we don't accept from the public.

e. Load Storage

Synergy Environmental Disposal Facility stores all material onsite until its treated, recycled, or disposed of. Waste material is removed by drop boxes hauled by Sunset Garbage Service. All metal is hauled by RS Davis in drop boxes. Any other waste streams are self-hauled to disposal points.

f. Waste Sorting

All sorting is done by employees of Synergy Environmental employees using hand and machine. We don't accept material from the public so there are no instances when the public would be in the sorting area.

g. Process for Measuring Recovery

Drop boxes are weighed at the disposal or recycling site and the quantities are sent to our main office for documentation. Liquid for recycling or disposal is placed in known sized containers and is documented upon disposal. Medical waste is weighed and documented, sewage waste is measured at the dump station and reported annually.

h. Waste Control

Waste control is done by employees who look at what is being processed and separate based on type of material. All material is kept within our fenced yard until disposal. Employees are trained on how to separate waste and where to store it while awaiting disposal or recycling.

i. Equipment Maintenance Schedule

All equipment is operated and maintained onsite by staff.

- i. All work on the equipment is done in the onsite maintenance shop. **(See Facility Map)**

j. Fueling

All equipment fueling is brought onsite by vendors. All other vehicles are fueled off site at fueling stations.

5. SWMP (Special Waste Management Plan)

a. Safety Program

The Synergy Environmental Disposal Facility has a comprehensive safety program that includes training, meetings, and inspections. Safety meetings are held and documented monthly, and a dedicated safety manager is available for inspections and questions.

c. Emergency Access

The gate is open during operating hours. After-hours access is available with a combination lock.

d. Personal Protective Equipment

The Synergy Environmental Disposal Facility provides PPE for its employees/ including but not limited to. High viz vests, hard hats, various types of gloves including Teflon sharps (stick-

prevention) gloves, safety glasses and face shields, leather aprons, dust mask, and Tyvek type suits. An allowance of \$60 per year is given to each employee to purchase steel toe work boots. We also utilize standard fluid spill kits.

e. On Site Fire & Emergency Equipment

On site emergency equipment includes but is not limited to: multiple fire extinguishers, spill response kits/ first aid kits, an eye wash station, and cell phones. There is no land line for the shop or office. There is not a fire-suppression/sprinkler system on site.

f. Spill Prevention and Response

The Synergy Environmental Disposal Facility and its employees make every effort to prevent spills before they happen. If a spill occurs, employees will make every effort to contain the spill before it spreads. The site manager will be notified as soon as a spill occurs or is discovered. Employees and management personnel are trained on spill prevention and response procedures.

Reportable spills include: Any amount of oil to waters of the state, oil spills on land more than 42 gallons, hazardous materials that are equal to or greater than the quantity listed in the Code of Federal Regulations, 40 CFR Part 302 (list of hazardous substances and reportable quantities) and amendments adopted before July 1, 2002. If a reportable spill occurs, The Synergy Environmental Disposal Facility will immediately report the spill to the Oregon Response System (OERS) phone number 1-800-452-0311. When reporting a spill, The Synergy Environmental Disposal Facility will provide basic spill information including type of material, quantity, location of spill, and contact information of The Synergy Environmental Disposal Facility. Some oil or hazardous material spills will require a separate notification to the National Emergency Response Center at 1-800-424-8803. The web site www.epa.gov/oilspill/oilreports.htm will provide The Synergy Environmental Disposal Facility with the information necessary to determine if the Synergy Environmental Disposal Facility needs to report to the federal system.

If a spill occurs:

- Move away or upwind from the spill if you detect an odor and / or are unsure if it's safe.
- Avoid contact with liquid or fumes.
- Keep non-emergency people out of the area.
- Wear protective clothing.
- Control and contain the spill.
- Clean up what you can immediately.
- Contact DEQ to confirm the appropriate disposal site for the contaminated materials.
- Remove the cleanup materials to the appropriate facility (save receipts for documentation)
- Continue with any long term clean up.
- File a report with DEQ. The form is available at www.deq.state.or.us/wmc/documents/spillreportform.pdf

g. Asbestos Testing and Waste Abatement Procedures

All vehicles/vessels will have an asbestos survey conducted by Chuck Canham with PDX Enviro. Once a survey has been conducted, the vehicle / vessel is marked with an "A" with orange spray paint. PDX Enviro takes the samples to Atlas Labs for testing. If the survey comes

back clean, the “A” is marked with a green circle around it indicating that it is safe to dismantle. If the survey comes back as “hot” or contaminated, the “A” is marked with a red “X” through it. Contaminated vehicles/vessels are then moved to our holding area (see site plan) to await asbestos abatement on site by Lyons Contracting. Once asbestos abatement is completed, the remaining materials are disposed of per the protocol that we follow for “clean” vehicles/vessels. (See section 3 – Operational Overview). We follow the same procedure above for all vehicles/vessels that we test from the City of Portland’s holding yard at 2619 NW Industrial St. Portland, Oregon 97210. Synergy Environmental Disposal maintains all documentation digitally.

h. Prohibited Waste Disposal Procedures

Other hazardous materials: Oil filters are drained, and the filters are disposed of. All petroleum and other hazardous liquids (anti-freeze, etc.) are separated and stored inside the facility until 50 gallons have accumulated. They are then moved outside to a secure Conex box (See Site Map). Fluids are picked up monthly (or as needed) for recycling by Orrco Oil Re-Refining Company. When possible, propane gas is burned for heat until it is empty, valves are removed, and tanks are recycled with scrap metal. Tanks that cannot be used are picked up and recycled by Cylinder Depot. Batteries are stacked on a pallet and picked up by RS Davis for recycling, biowaste from gray and black water tanks is pumped into 275-gallon IBC containers and transferred by Synergy Environmental to Clean Water Services for disposal. Refrigerant is removed on site by Rapid Recovery HVAC contractor. Other hazardous liquids are picked up by WasteExpress.

i. CRT’s & Fluorescent Bulbs

CRT’s and fluorescent bulbs are removed from vehicles that are brought into the facility for demolition. Fluorescent bulbs are collected/separated and stored for pick-up by URT. Employees do not attempt to remove any portion of the CRT from its housing or television cabinets. All CRTs are collected by employees wearing proper PPE which includes safety glasses, puncture resistant gloves, long-sleeved shirt, long pants, and closed-toe shoes, even if the CRTs are not broken. Broken CRTs are cleaned up immediately. The material from broken CRTs is dampened for cleanup and kept damp for the whole clean-up process with a wet mister and then the material is carefully scooped up with a hand broom and collection pan. The remaining small glass fragments are collected using duct tape. The area is then mopped. All material, including glass, is placed in double plastic bags inside a sturdy box. Unbroken CRTs are bagged and boxed as well. The box is then closed and sealed securely with tape to ensure that everything is contained properly. All boxes are labeled as either Fluorescent Bulbs or CRT/Broken Cathode Ray Tubes-CRT's. Boxes are stored on pallets in our designated storage area. When full it is picked up by URT located at 10151 SE Jennifer Street, Clackamas, OR, 97015. Phone number is 877-278-0799.

j. Waste Tires

Waste tires are obtained from RVs brought in for demolition and picked up from illegal camp sites throughout the city. They’re de-rimmed and then stored in a transport truck for transport. Rims containing lead weights are sent to RS Davis for recycling. The weights are not removed from the rims. When the truck reaches a capacity of 100 tires, they are transported by Rapid Response under our Waste Tire Hauling (Permit #1724 Attached) to Tire Disposal Company at 14377 S. Macksburg Rd. Molalla, Oregon 97938. Phone number is 503-829-8405

k. Grey and Black Water

Grey and black water is removed from RVs prior to deconstruction by suctioning out the tanks from the discharge fitting into our DEQ permitted sewage truck (Permit #39171 Attached) It is then taken to Clean Water Services in Tigard and disposed of under their guidelines where it is dumped into a sewer treatment system. Buckets of mixed urine and sewage are brought back to the facility and dumped over a strainer into a tank. The tank is suctioned out by our sewage truck and transported weekly to Clean Water Services in Tigard and disposed of under their guidelines. Needles and other foreign objects are removed from the strained debris, and either placed with medical waste or dried and disposed of with other solid waste.

l. E-Waste

All E-Waste is placed in a cardboard tote. Totes are stored on pallets in our designated storage area. When totes are full they are picked up by URT located at 10151 SE Jennifer Street, Clackamas, OR, 97015. Phone number is 877-278-0799.

m. Batteries

All batteries are stored on a pallet separated layers by a cardboard sheet. When we collect 4 layers of batteries, we shrink wrap them and call RS Davis to come pick them up. (Stored Inside Facility)

n. Mercury Switches Switches are removed and placed in a 5-gallon lidded bucket labelled *Mercury Switches* and picked up by URT when full. (Stored Inside Facility)

o. Radiator Cores Radiators are drained, removed, and sent to RS Davis for scrap metal recycling. (Stored Inside Facility)

p. Airbags Undeployed airbags are removed and placed in a 55-gallon drum marked *Undeployed Air Bags*. The drum is provided by Clean Harbors. When half-full, Clean Harbors dispatches a truck to pick up the drum(s) and transport for recycling. Clean Harbors is located at 16540 SE 130th Avenue, Clackamas, OR 97015. (Stored Inside Facility)

q. Paint. In the event that paint is discovered during the dismantling of an RV or Boat, latex paint is poured into a 250-gallon holding tank. Oil-based paint is poured into a 55-gallon drum. When containers are full, Waste Express picks them up and drops off new, empty containers. (Stored Outside Undercover).

r. Infectious Waste (Sharps) We receive infectious waste from veterinarian clinics, hospitals, medical clinics, tattoo parlors, Multnomah County Syringe Dropbox program. Sharps are received in FDA approved sealed containers. These containers are never opened. The sealed sharps containers are placed directly into the Red Bag Machine Model SSM-150 for processing. The door on the machine is Closed and, the processes is started. Hot water is added to the tank. Contents continually circulated through the internal cutting system, and macerated The Red Bag Machine has internal blades that chop the material into smaller pieces while simultaneously using heat and pressure to completely sterilizes, while an internal magnet removes the needle portions. The sterilized needles are removed from the discharge container placed into a rigid lidded container (i.e., 5-gallon bucket) and recycled as (scrap metal) at RS Davis. After this process, the solid material is discharged into an external grinder that further sizes the plastics smaller. It is then transferred to a secondary grinder for preparation of moving to the float tank. This plastic material is then floated in a tank of water that allows the polyolefins (the premium material) to float and the rest of the material to sink. Several magnets in the float tank are used to remove any remaining metal. The material that sinks (about 10% of the processed material) is then discarded as solid waste.**(Infectious Waste)** When we receive red plastic bio-hazard bags

which may contain linens, sharps containers or other bio-hazards, we do not open or handle those bags other than to place them into 43-gallon lidded tubs for truck-to-truck transport to Trilogy Medwaste on a weekly basis. (address listed in Operations Overview). We then receive empty/clean containers in return. The 43-gallon totes are shipped weekly to Trilogy.

6. Job Duties & Hiring Practices

a. Site Manager

- i. Monitor all inbound vehicles.
- ii. Monitors all deconstruction activities.
- iii. Ensures all proper safety requirements and procedures are followed.

b. Employee Standard – Rapid will:

- i. Comply with Oregon’s “ban the box” law (ORS 659A.360) which makes it unlawful for an employer to inquire about criminal convictions before the interview stage of hiring.
- ii. Maintain a copy of the facility’s employment application on the facility premises and in a location where facility personnel and Metro representatives have ready access to it.

7. Personnel Training

Each employee is trained in the entire dismantling operation. They receive specialized training based on their specific job duties.

- Biohazard
- Excavator
- Welding
- CPR and First aid
- CRT’s
- Spill Response
- Sharps Training

Closing Procedure

In the event of a short-term cessation of operations (7 days to 30 days), management will contact all customers and advise them of the approximate time the closure will be in effect. The gates will be closed, and a sign will be posted on the gates advising of Temporary Closure. All outbound material will be transported as soon as is feasible. RRBC will advise DEQ and Metro of the nature of the problem, the proposed resolution, and the approximate time of re-opening.

In the event of a long-term cessation of operations (permanent closure) management will contact all customers, DEQ and Metro. The gates will be closed, and a sign will be posted on the gates advising of Permanent Closure.

In the event of short-term or long-term facility closure, all waste stockpiles and waste residues will be removed and disposed of in accordance with existing permits and site will be restored to pre-operating conditions with all debris removed and no longer present.

in the event of some unforeseen circumstance that forces us to shut down operations, we anticipate all costs associated with waste removed to be covered.

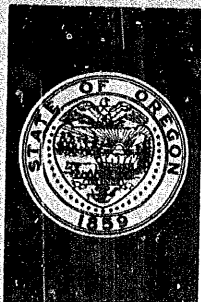

This will acknowledge your letter dated January 25, 1971 in which you requested our comments with regard to the proposed solid waste landfill site (Mt. Scott Gravel Company, Inc.) located between Johnson Creek Boulevard and Overland Street, on property described as Tax Lots 70, 71, 72, 77-1, 78-2, 79, 80, and 95-1, Section 29, T1S, R2E in Clackamas County. Several field surveys of this site have been conducted by Associate District Engineer Robert E. Gilbert.

Based on these preliminary surveys, it is our opinion that the Mt. Scott Gravel site could be considered feasible for a non-putrescible solid waste site. This opinion in essence concurs with the Planning Commission's actions regarding this site as detailed in your letter dated January 14, 1971. In that letter you granted the application for a Conditional Use Permit to establish a landfill subject to eleven (11) conditions. Basically we agree with these conditions; nevertheless we would like to make the following recommendations:

1. The disposal site must be operated as a sanitary landfill with complete compaction and earth cover of all wastes, a minimum of once each day.
2. Prior to the acceptance of all non-putrescible solid wastes, the pit shall be filled above the high groundwater table, by using inert materials. Inert materials may include such items as rock, dirt, brick, cement, or tires (chipped or baled).
3. No putrescible wastes, sewage sludge or septic tank pumpings, hazardous or toxic chemical wastes, liquid wastes, oils, etc., shall be accepted in the fill.

4. All surface water drainage shall be diverted around the landfill so that water will not drain into or through the fill.
5. Prior to the opening of the site a 6' sight obscuring fence shall be constructed around the entire property.
6. Water under pressure must be provided at the site for fire protection as outlined in the Department of Environmental Quality - Oregon State Board of Health Rules and Regulations.
7. No salvage accumulation would be allowed.

This letter does not constitute an approval of the proposed disposal site. The detailed recommendations outlined above must be incorporated into plans and specifications and be submitted to the Department of Environmental Quality for review and approval prior to operation of any such landfill (OAR-CH.333 - Subdivision 8). Enclosed please find a copy of the publication entitled "Information to be Required and Included in Sanitary Landfill or Landfill Plans" which should be used as a guide.

The Oregon Health Division (OHD) has reviewed the application submitted for approval of the use of the **Antaeus SSM-150** system as an alternative treatment methodology for infectious waste. Your application is approved under the following conditions:

1. All waste must complete a full cycle in the **Antaeus SSM-150** system (maceration and steam/super heated water sterilization at 250° F for 30 equivalent minutes). Failure to complete a full cycle will necessitate retreatment until a full cycle is completed or handling and disposal of the incompletely treated waste as infectious waste.
2. All records emanating from process monitoring, including tests of efficacy using accepted microbiological methodologies, shall be maintained and available for OHD review for a period of not less than one year.
3. The OHD reserves the right to require periodic tests of efficacy should concerns arise regarding the level of disinfection attained when in actual use within the state.
4. This approval applies only to waste generated by the facility responsible for operating the system. Any other applications may warrant the Oregon Department of Environmental Quality (ODEQ) approval as a solid waste transfer station.
5. Any changes in operating procedures or equipment must be approved by the OHD prior to their implementation in Oregon.
6. Any discharges into the air or water and disposal of any solid waste resulting from the system must meet the requirements of the laws and administrative rules of the ODEQ.

7. Other than pathological wastes, all other categories of infectious waste (sharps, cultures and stocks and biological wastes) may be treated with this system in Oregon.

All pathological wastes must be incinerated unless ODEQ proclaims otherwise.

Hazardous chemicals, including radioactive wastes, are not to be subjected to this process.

8. All sharps treated in this system in Oregon must be contained in a red, leak-proof (sides and bottom), rigid, puncture-resistant container. Such containers must be secured against loss of contents during storage and transportation to the destination of treatment or disposal. The container must be conspicuously labeled with the international biohazard symbol and the words "Biomedical Waste", "Biohazardous Waste", or "Infectious Waste" so as to be readily visible from any lateral direction when the container is upright.


9. This approval will not preclude requirements for special accommodations for solid wastes treated in this system or resulting liquid discharges by solid waste personnel responsible for transportation, transfer stations and/or disposal sites or sewerage authorities.

10. This approval of the process and technology shall not be construed by any party as an endorsement of the system.

11. Failure to abide by any of these conditions may result in revocation of this approval.
