

What We Did

We shared the take-aways from our roundtable discussions and staff engagement with four stakeholder groups:

- Regional Waste Advisory Committee
- Committee on Racial Equity
- Metro Policy Advisory Committee
- Metro Council





What We Heard

Regional Waste Advisory Committee

- Hopeful for visionary scenarios
- Fill gaps with facility and non-facility options
- Preference for smaller, distributed facilities across the region
- Consider:
 - Recycling Modernization Act
 - Disaster preparedness
- Involve reuse and repair organizations in developing scenarios



What We Heard

Committee on Racial Equity

- Provide information in multiple languages
- Take action on waste reduction
- Recognize that smaller organizations have role in waste reduction too
- Close feedback loop with engaged audiences
- What elements of case studies could work in our region? Any Oregon examples?

Metro Policy Advisory Committee

- Need for affordable and accessible services in Washington County
- Local jurisdictions and private sector are expanding curbside recycling services
- New or improved facilities should be built to be resilient to climate change
- Evaluate level of service differences and costs between public and private facilities





What We Heard

Metro Council

- Want to understand options besides building additional large facilities, such as increased collection services or a network of small neighborhood-based depots
- How will changes in residential services be incorporated in scenarios?
- Assess how each scenario will impact rate payers; solutions should provide both value and efficiency
- Suggested adding research on jobs and workforce development as part of the technical analysis
- Involve reuse and repair organizations in developing scenarios
- Council would like to see maps of possible locations for future facilities to increase access and reduce travel times

• What facilities are needed to reduce the demand for garbage services and focus on more reuse, repair and recycling?


Priority Materials


