Co-chair Burt Edwards opened the meeting and started introductions.

Burt went over optional member check-ins with staff and co-chairs and introduced the agenda.

MG Devereux reminded attendees of the process for public testimony.

No formal testimony was received since the last meeting, though members of the community have continued to be in touch with staff regarding concerns over the City of

Staff:

Portland's Rose City Golf Course project. Staff have been following up with Portland staff regarding these concerns and will keep the committee updated.

MG asked members to share updates and intersections in the bond work.

PK Melethil shared a positive experience working with <u>Friends of Trees</u>, where many community members came from across the region to participate. He praised the community-building aspect of the project and interesting nature of the work in an urban landscape. Cary Watters also appreciated the work done by this organization.

MG reminded members to submit updated conflict of interest forms for the year.

Burt introduced the committee recruitment discussion agenda item and noted his co-chair appointment ends in March, so a new co-chair will need to be appointed.

Beth thanked Burt for his service and provided a status update on the committee recruitment and plans for a future sustainable committee (*refer to slide deck*).

There has been natural attrition of membership since the committee origin.

Membership can range from 9-21 members, and we currently have eleven. Terms are staggered, and members can serve up to three two-year terms.

Council established a range of expertise and lived experiences we hope to include in the membership to represent the diversity of the region.

Recruitment strategies so far has included posts to Metro websites, Instagram, Facebook, and LinkedIn, direct email lists, listserv posts, staff and Council network sharing, and current members sharing within their own networks.

Beth provided a broad demographic and experience snapshot of the current application pool. Many applications are still clustered in Multnomah County, and broad geographic representation is still a goal.

Internal review is underway, and a recommendation will be moved to Council President Peterson in April to appoint 1-5 new members.

The co-chairs opened discussion for comments, suggestions and questions.

Cary hoped each committee member would make contact with at least one individual who could be a good fit and could share recruitment within networks and platforms.

Burt asked for ideas on reaching Washington and Clackamas County applicants as well as potential youth applicants.

John Ferguson asked if a balance of expertise and interest in the three working group topics are focused on specifically.

Beth clarified that there is alignment, but that the expertise and experience sought is broader than those three topics. We can also adjust working group topics to fit committee interests and needs.

PK stressed that Metro should reach out to as large a group as possible to get the best representation of public desires and needs (on this and future measures).

Councilor Rosenthal noted the front end reach out on bond work to determine community wants and needs, as well as this committee's looking back to evaluate if Metro is meeting its promises with the bond measure.

Shannon Shoul shared an opportunity for youth outreach in the Beaverton School District.

Cary asked about outreach to the Coalition of Communities of Color, the Oregon Lead Program for the Native community and the Bridges Network.

Beth shared that there was outreach to the Coalition of Communities of Color, Verde, EcoTrust's leadership program and other organizations. Councilor Hwang and other Councilors have been sharing through their networks. We can continue to add to the list for outreach.

Burt asked about local television, ads and press to extend outreach.

Beth noted the broader sharing is generally at an agency level. We are trying to raise awareness for committee recruitment, so this is helpful feedback.

PK suggested Metro staff and co-chairs could speak about committee membership and put out a brief video to give committee perspective.

MG felt this could be useful to explain the committee to potential applicants. Media hasn't been used broadly beyond our extensive use of social media channels for the department and the agency.

Burt suggested applicants should share where they first heard about the opportunity to help inform ongoing outreach.

Burt asked members to continue to reach out to staff and co-chairs with ideas.

#### Burt introduced the bond spend down trajectory discussion item.

Jon Blasher thanked Burt for his service as Co-Chair, provided an overview of overall bond finance logistics and introduced the overall spending targets for the bond (*refer to slide deck 2*).

A 12-year spend down is planned, spending \$475 million by 2031 (includes \$200 million in awards to park providers and community organizations.)

Short term goals by September 2024 include an anticipated spend of \$63 million and an anticipated award of \$75.7 million. Jon highlighted various program spending milestones.

Ion outlined opportunities and headwinds regarding the spend down plan.

Jon opened to group discussion and questions.

PK shared about conversations with Shannon Leary and other staff regarding land acquisitions and funding over the life of multiple bonds for over 30 years to achieve Metro's vision. The details are welcome, especially over a broader time span.

Shannon also clarified that the broader information was a look back at completed spends and the materials today are spending projections for spending yet to come.

PK noted the map shared with the committee in November/December with the details on acquisitions for land acquisition and noted a desire for detail in information.

Councilor Rosenthal asked if the committee could benefit in a deeper dive into the large scale community visions program updates underway based on participant feedback after the pilot round.

Jon shared that the committee had a presentation on the program at a previous meeting and provided high level overview of the pilot round and updates on planned adjustments to the program handbook.

Match requirements are being adjusted, segmented property components rather than a contiguous requirement, and the timeframe for the funding to be most impactful.

John shared his positive impression of the land purchases to date regarding habitat connections. He noted that large parcels haven't been available. He has heard feedback asking when the next big park is coming. Are there any opportunities for another big purchase?

Jon said yes and noted Chehalem Ridge and Newell Creek successes recently. The portfolio growth has increased cost to operate and maintain at a high level of standard and service, and we need to think of what the region needs from Metro Parks and Nature so we can fill those gaps. Staff are also working over years for generational opportunities as they arise.

Shannon Leary noted the long incubation for the larger parks from first purchase to development and went over the criteria for land acquisition. She shared about a recent purchase about to be announced for a target area that has not been worked in before (Molalla Oaks Floodplain outside Canby with Pudding River frontage).

Beth shared on the thinking behind bringing the spending targets forward for a contextual framework and foundation for the committee as they evaluate bond work and achievements.

Burt noted it's hard to tell how the overall spend trajectory relates specifically to climate resiliency and asked how that could be shared/shown.

PK asked the committee for feedback on the map that was mailed out to the group.

Martita loved it as a resource offering information on the different types of land.

Georgena enjoyed the map, felt it was thorough and added dimension.

Councilor Rosenthal noted the committee provides its own "audit" on the bond work, and noted the response to the Metro Auditor's program audit of the bond and its focus on accessibility.

Jon shared an update on the response work and ongoing engagement and updates to Council and the committee. Looking and thinking about the definition of access and what it looks like, equitable access, methods of measurement, etc. The bond outcomes work is where much of this will continue to appear. We want to show that input on this topic is being implemented in the bond work moving forward.

Councilor Rosenthal noted Council will also have to work on these questions as well.

Beth also noted this is a potential topic for the May meeting, and staff can share progress, tools and plans.

The committee annual report this fall will look at access measurement, articulating bond impact on communities in the region, a visualization tool and ways to communicate with multiple audiences. A mapping component is also being worked on.

John noted that the best natural areas are beyond the urban core, and that access has to do with transit to those areas. Blue Lake Park, which is relatively close in doesn't have bus service. There has been discussion on partnering with transit services. Has there been progress on that?

Jon shared that internal ArcGIS mapping has helped look at transit proximity to Metro sites. A Council briefing for the tool is planned. Parks has been working with Planning on the transportation questions regarding the current portfolio.

The bigger conversation is also how to create broader transit access to all regional parks and trails. The regional transportation plan also has a section looking at access to transit (chapter 8). Considering that last mile gap to fill for parks. Parks and Planning are looking at the access from the transit angle to make plans for more coordination with other agencies.

Councilors Nolan and Rosenthal were very happy about the coordinated work on this topic, and Jon plans to follow up with the Councilors.

Jon noted the department has been trying to look at experiences people would seek at some larger, less reachable sites and show/highlight other sites that would provide similar experiences that could be more easily reached on transit.

Burt suggested a discussion topic on access at a future meeting and hoped for another inperson gathering at a site like last year's.

Beth introduced the committee workplan agenda item (refer to slide deck).

The next meeting is likely in May with working groups to follow. The work plan to respond to the audit is a likely agenda item.

Committee members were requested to respond to a survey (*link in chat*) to rank possible topics shard on the slide deck.

PK thanked members for feedback on the map and asked the Councilors if they got the map. He noted the usefulness of the map to capture a lot of detail to understand the land acquisitions over time. Hopes for more detail moving forward and thought it could be a useful tool for youths, as well.

Staff confirmed that Council had not received printed copies and will get each of the liaisons a print.

Councilor Rosenthal appreciates maps and requested that climate justice discussion be as specific as possible to provide the best guidance.

Burt asked about language on climate justice in the bond. (Noted resilience and equity are present).

Beth can check on the terminology in the bond measure. There is overlap and overlay in the terms, and that's a good point for the committee to explore.

Cary shared that she worked for the Native American Youth and Family Center and they had formed Climate Justice Collaborative with Opal Environmental Justice Oregon, Coalition of Communities of Color and other organizations serving communities of color. She shared the <a href="implementation plan.">implementation plan.</a> They used a broader definition of climate justice.

Cary suggested a topic related to her work on the Clean Air Construction Collaborative a regional collaborative effort to reduce diesel particulate emissions on construction projects. Metro, Portland and other agencies are participating, and Blue Lake Park was the first project using the new requirements. We can look at opportunities coming up.

Burt asked about COBID participation as a topic.

Beth noted that the topic has been explored in the finance working group but not in depth to the broader group beyond the general reports. It can be a topic for the future. There is a contractor equity focus on the bond in alignment with the Construction Career Pathways program. Some bond programs are good examples of this.

Beth suggested that the upcoming working groups can also explore topic suggestions.

Cary was interested in more contract equity discussion and has suggested disaggregation of the data by race and gender identity for a fuller picture in group discussions. She'd like to see more of the data on the workforce equity.


Georgena liked the idea of a future meeting focusing on access issues and transportation-related access issues.



## Big picture | 12-year spend down





# Mapping discussion

- Group discussed the copy of the map that the committee received last fall and saw at Scouters
  Mountain and additional spatial layers that the committee may want to use in its evaluation and
  oversight work including all acquisitions completed since the 1995 natural areas bond measure. Staff
  committed to sharing this map back with the committee in the coming month or two.

# Land acquisition spend down

- As a follow up to the presentation at the February 27 about trajectory of bond spend and award,
   Shannon overviewed the anticipated pace of spend down for the protect and restore program area
- Shannon overviewed the eligible categories within the protect and restore program area including land acquisition, stabilization, capital restoration, community led acquisition project
- Group discussed the total amount anticipated for spending on land acquisition (around \$80 million) through the total amount of the protect and restore land program, which is \$155 million

# Capital restoration projects

- Jonathan introduced the 8-9 capital restoration projects that have been prioritized for bond funding through the protect and restore program and promised to send follow up to working group with a list and brief description of each project.
- Group discussed how input from tribal governments has been and is being incorporated to shape restoration priorities. Jonathan shared how the focus on priority species (salmon, lamprey, and water as a priority habitat) in the capital restoration projects is aligned with feedback.
