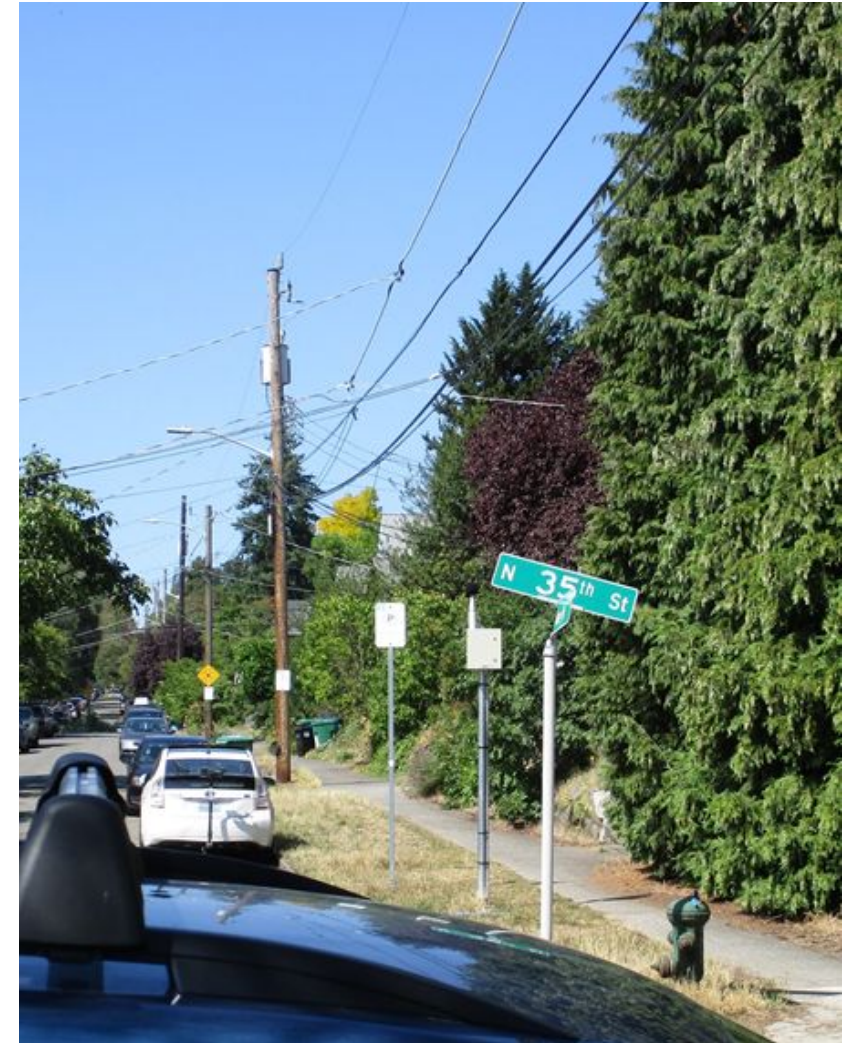

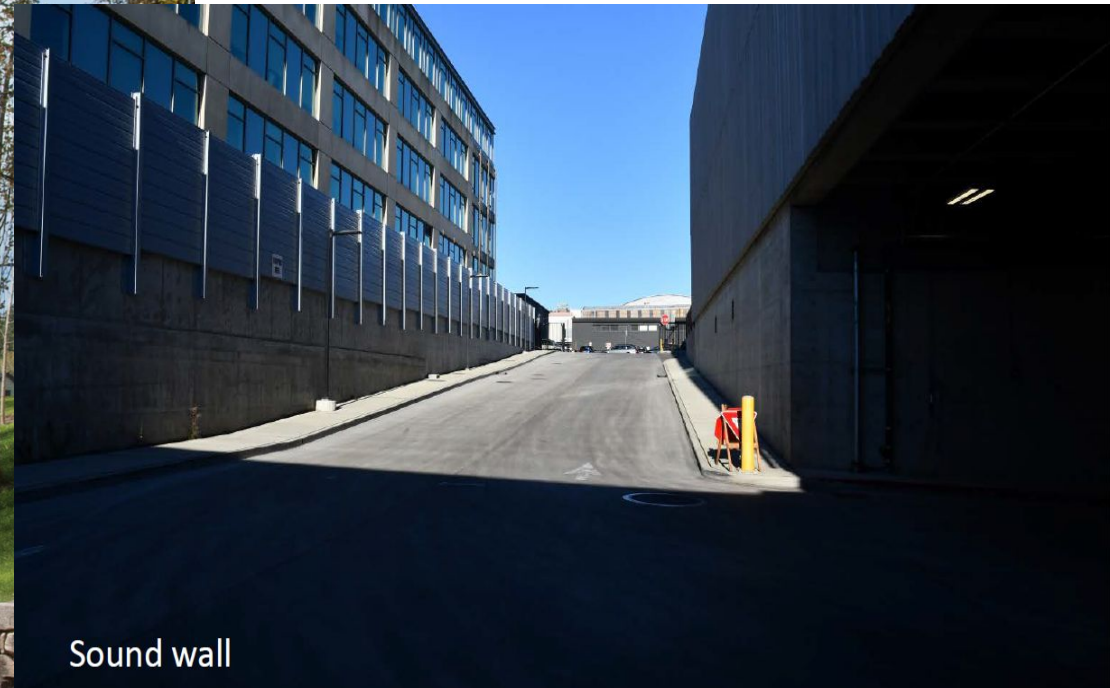

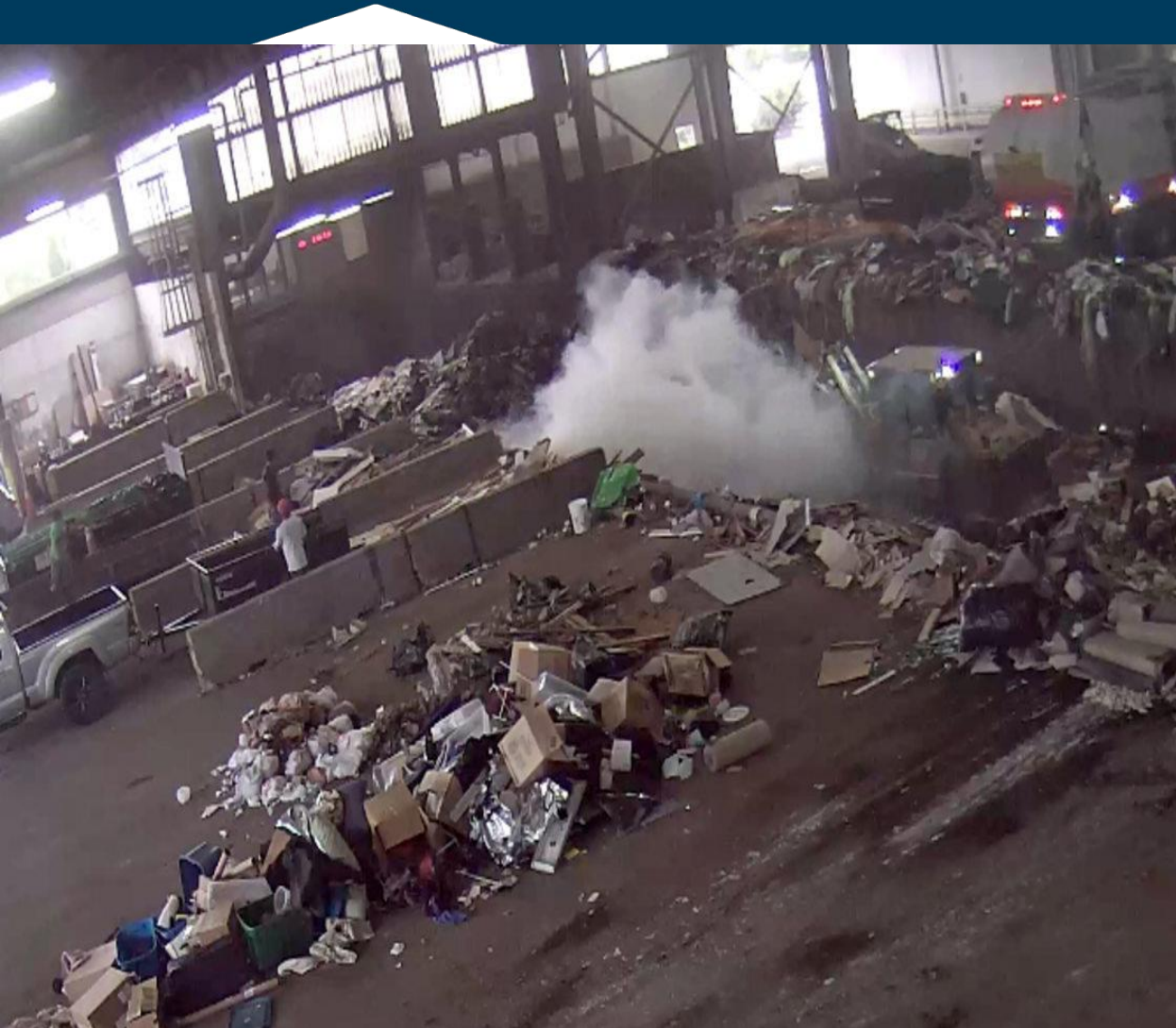

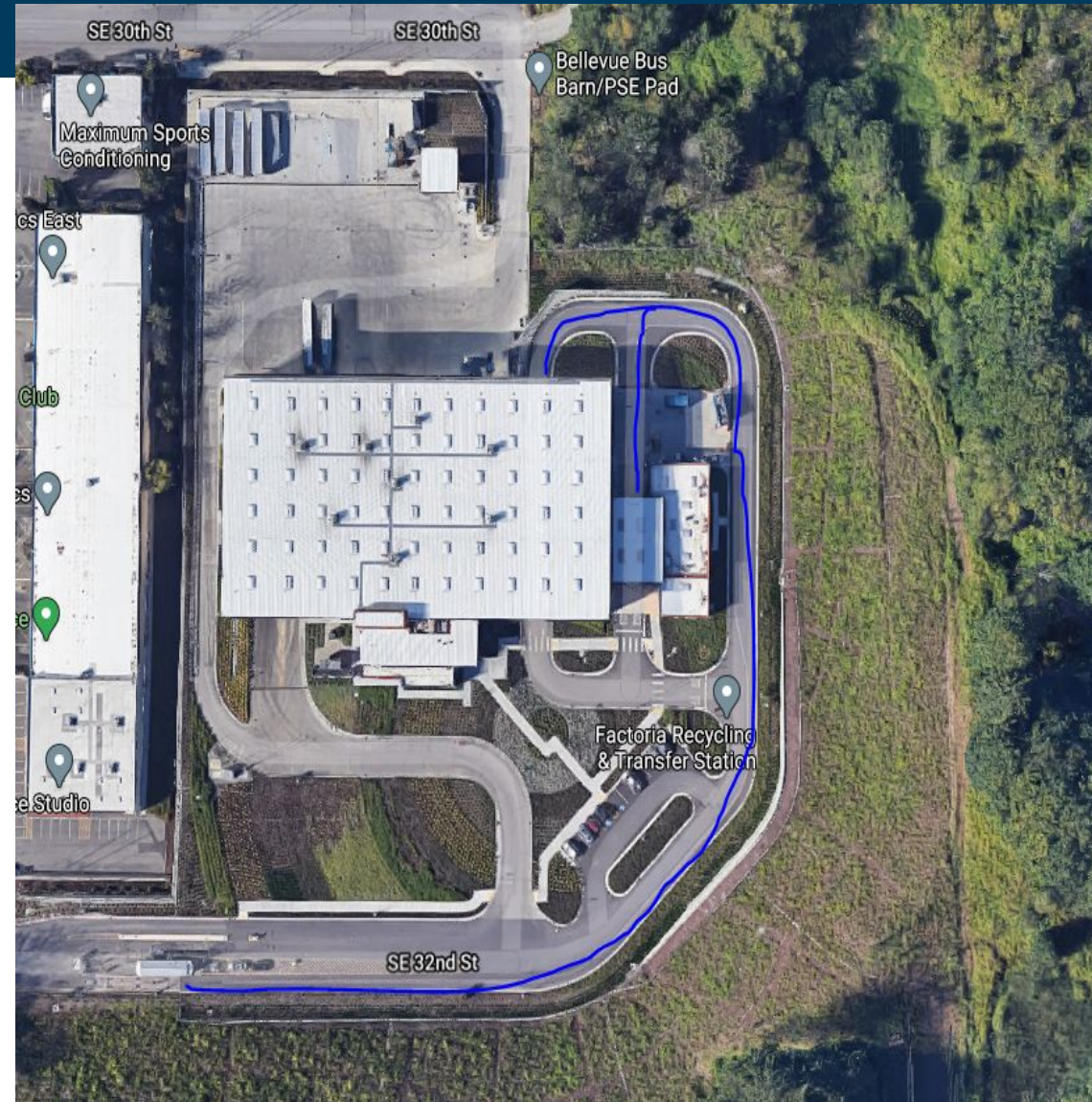

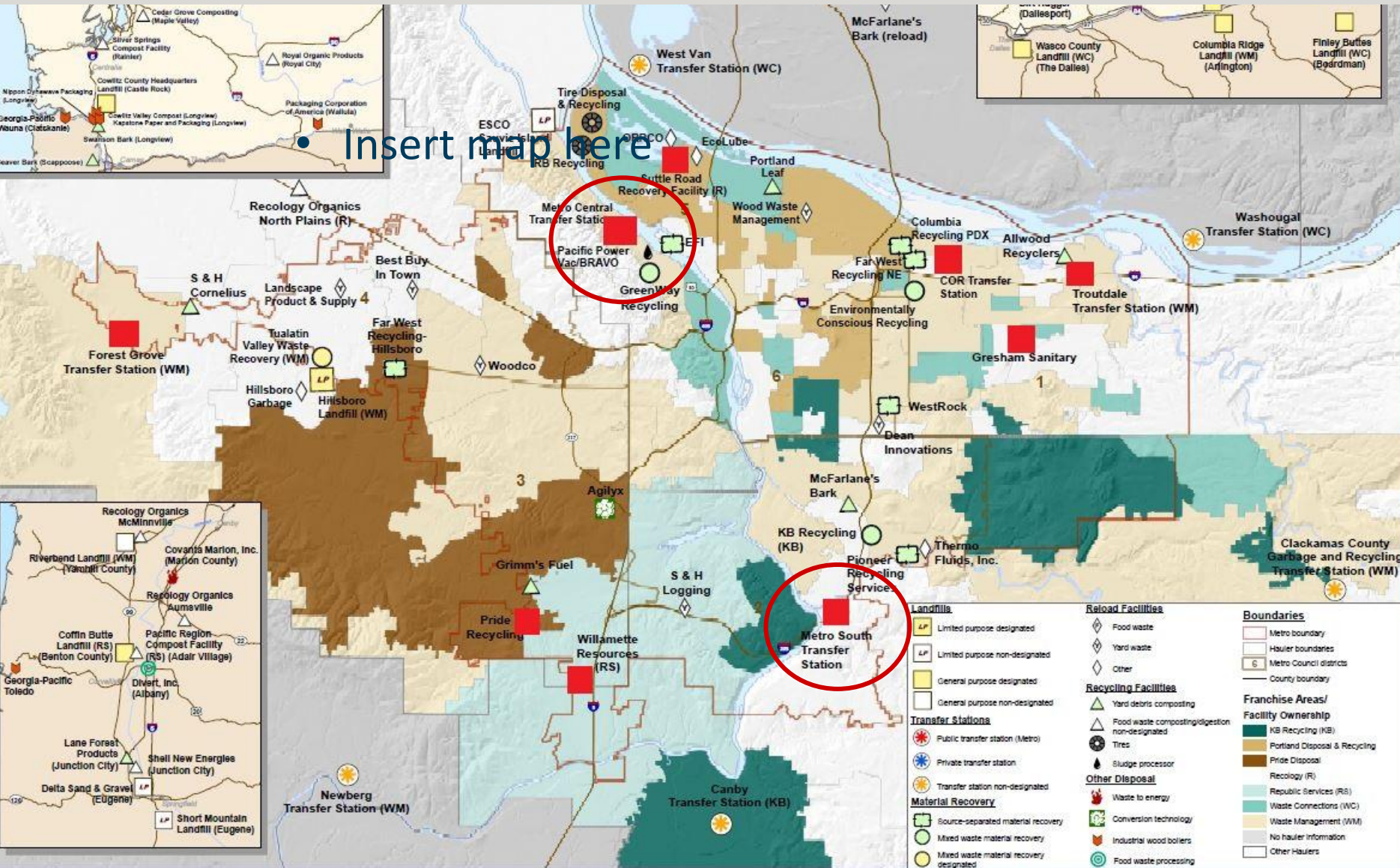
# How does it work? | ¿Como funciona?

- Since 1986, Metro has provided CEG as a way to support and invest in communities that host solid waste facilities.
- \$1 is generated for every ton of putrescible waste that comes through a facility
- Dry or construction waste along with yard debris is exempt

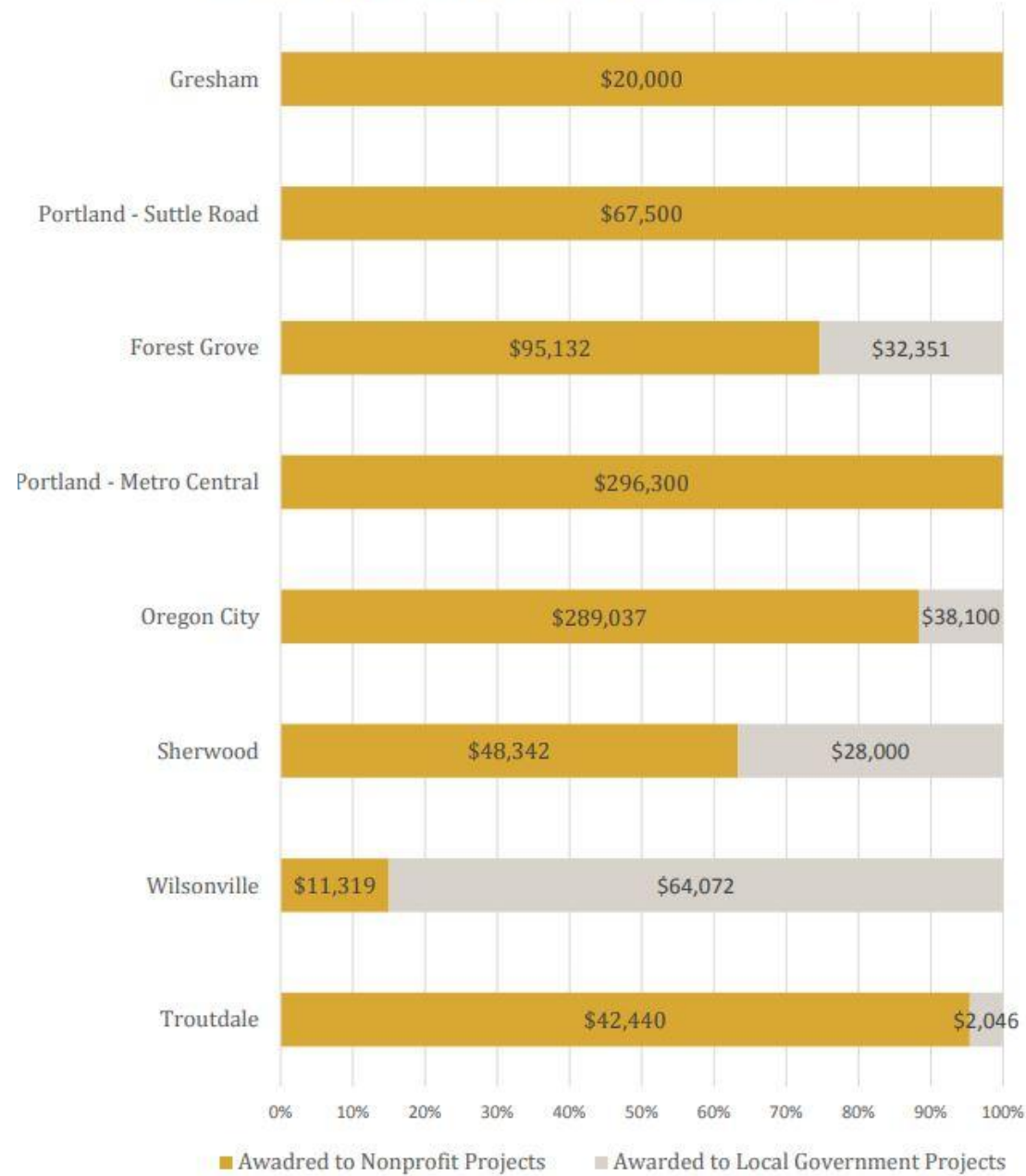

Grants Recipient Type by Jurisdiction FY 18-19

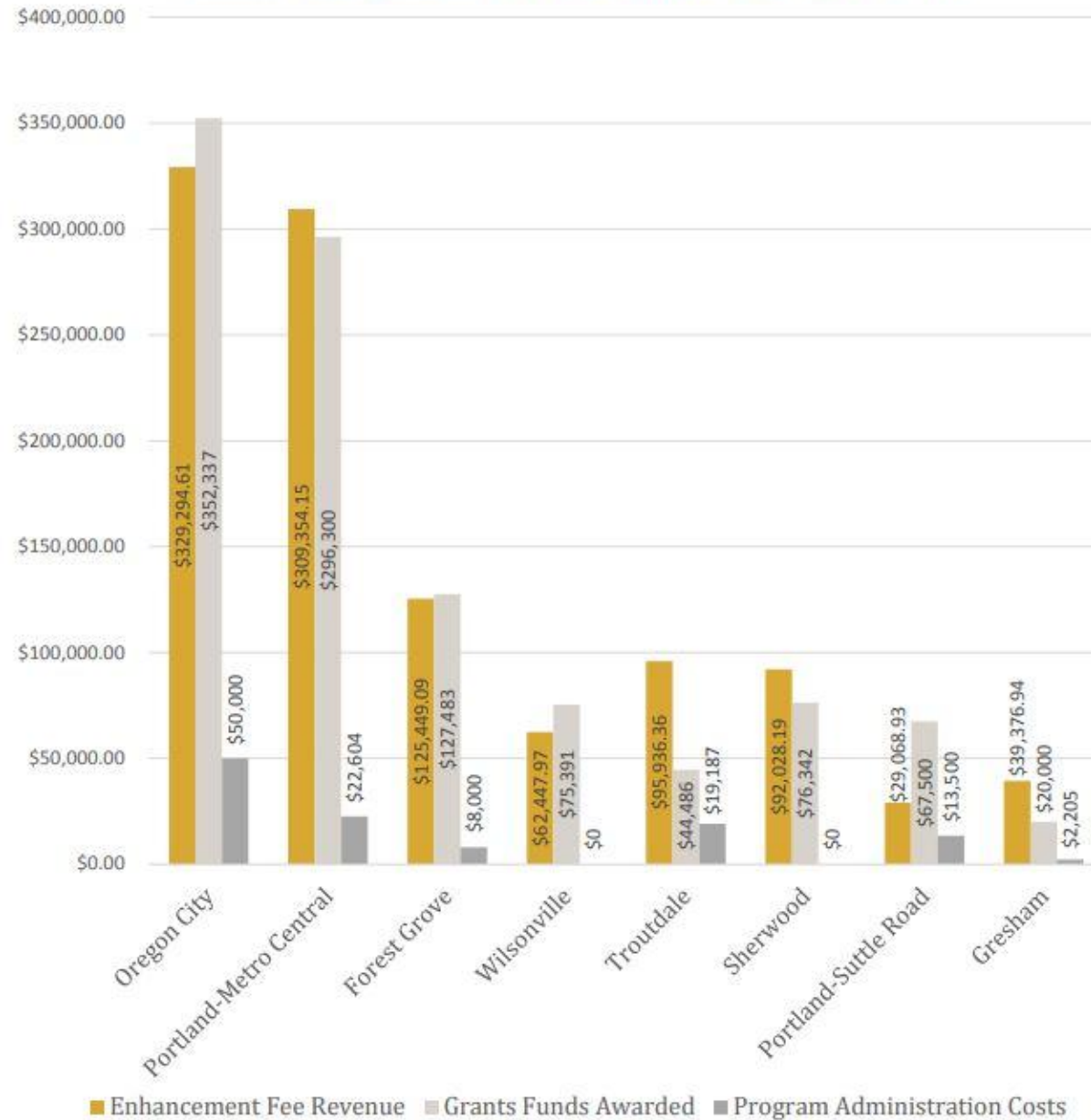

# How is a grant program initiated?

## ¿Cómo se inicia un programa de subvenciones?

1. Host city > Metro > nonprofit organization (IGA or contract)
2. Organization administering grants establishes a grant committee
3. Grant committees can be comprised of elected officials and/or community members
4. Grant committees make decisions on the enhancement boundaries and awards
5. Funds generated must be awarded within 3 years

# CEG Roles and Responsibilities | Roles y Responsabilidades

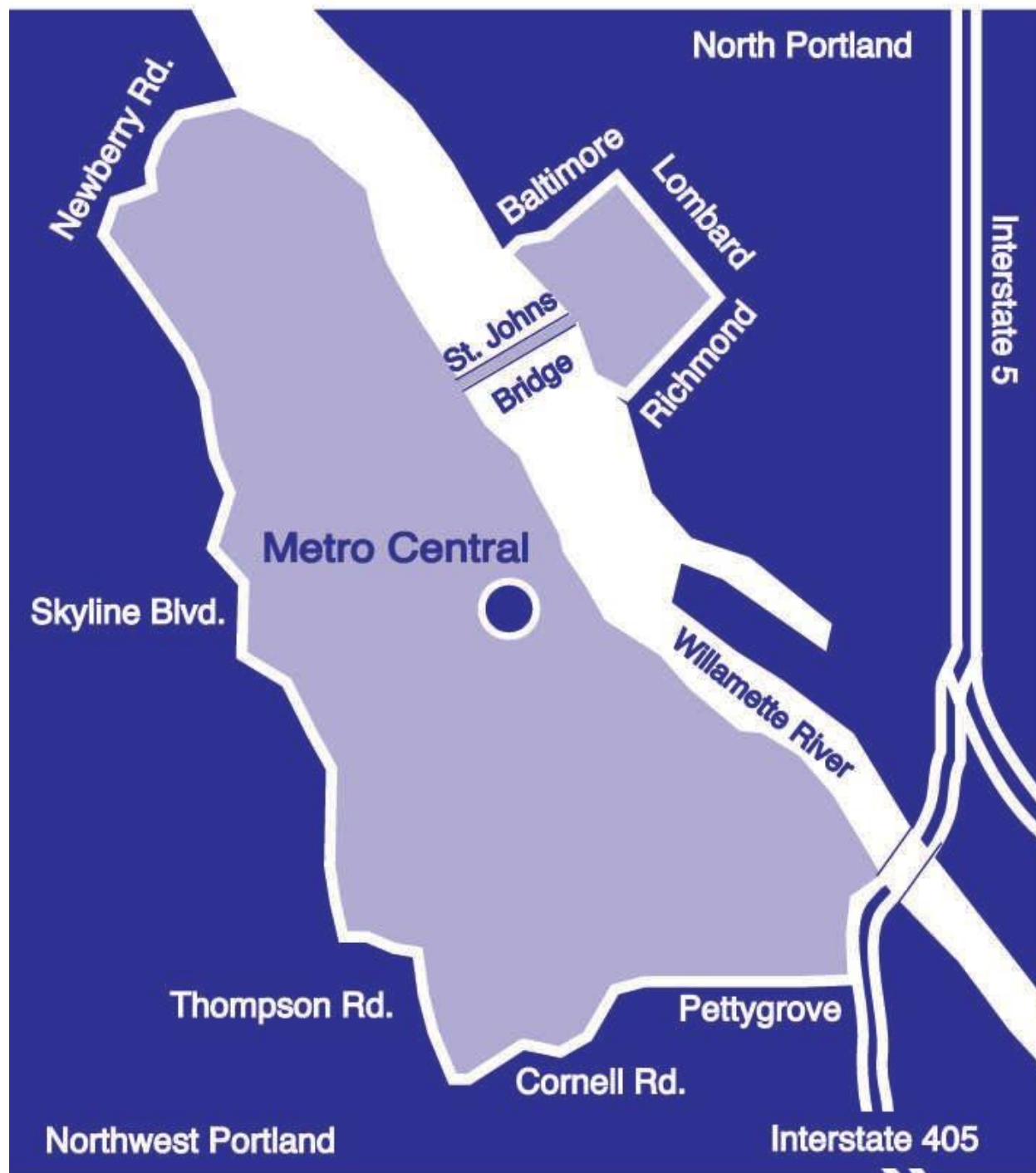
Host City or Organization	Grant Committee	Metro Grant Staff	Metro Council
Enter into an intergovernmental agreement with Metro	Have vested interest and knowledge of community need	Administer intergovernmental agreement between Metro and city or contract with organizations	Approve enhancement grant code and administrative rules
Create grant committee (often city elected officials with some community members)	Establish and maintain committee bylaws	Support host city or organizations as well as grant committees to meet requirements in Metro code and state law and provide additional resources as needed	Ability to sit on and at times act as chair or co-chair of any grant committee that resides in councilor's district
Staff time allocated to program administration (i.e promotion, budgets, payments, records, applications, grantee communications)	Establish and define enhancement boundary	Oversee and distribute revenue generated by qualified solid waste facilities across region.	Approve committee members for any grant administered by Metro staff (most grants are administered by other jurisdictions so this currently only applies to Metro Central' CEG)
Provide annual grant report to Metro staff	Approve annual budget for grant cycle, award details, and promotional material and application questions	Develop regional grant report to the public	
Support grant committee as needed	Establish and maintain method for scoring and ranking grant applications

	Review applications and award grants to applicants		



# Eligibility | Elegibilidad



1. Located in **or benefit those** in target area
2. Nonprofits, local governments may apply
3. May not replace other readily available funds
4. May not promote or inhibit religion.
5. Must not discriminate based on race, ethnicity, age, gender, or sexual orientation.
6. If project on private land, must document landowner permission.





# Community Enhancement Grant Program Goals

## Metas del programa CEG

- a. Improve the appearance or environmental quality of the community.
- b. Reduce the amount or toxicity of waste.
- c. Increase reuse and recycling opportunities.
- d. Result in rehabilitation or upgrade of real or personal property owned or operated by a nonprofit organization having 501(c)(3) status under the Internal Revenue Code.

## CEG Goals Cont. | Metas continuado...

- e. Result in the preservation or enhancement of wildlife, riparian zones, wetlands, forest lands and marine areas, and/or improve the public awareness and the opportunities to enjoy them.
- f. Result in improvement to, or an increase in, recreational areas and programs.
- g. Result in improvement in safety.
- h. Benefit youth, seniors, low income persons or underserved populations. [Ord. 14- 1344.] 5.06.090 Compliance and D

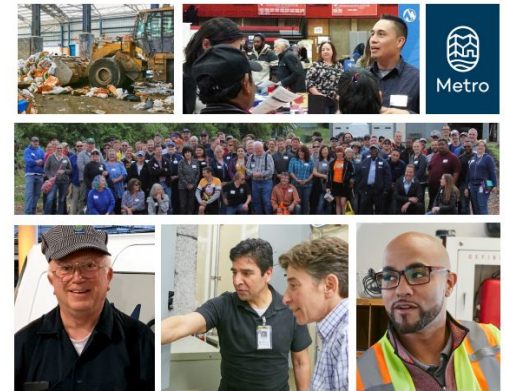

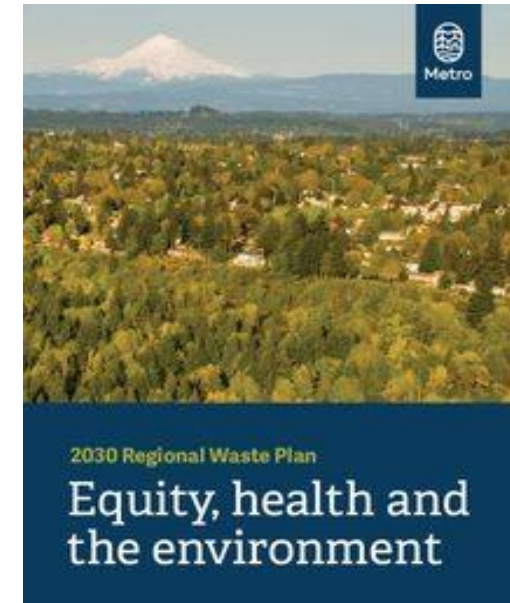

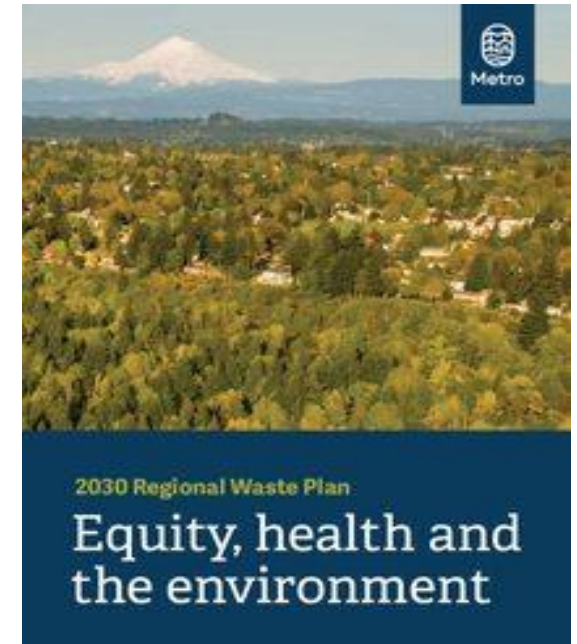
