Center racial equity by including representatives of marginalized communities in its development

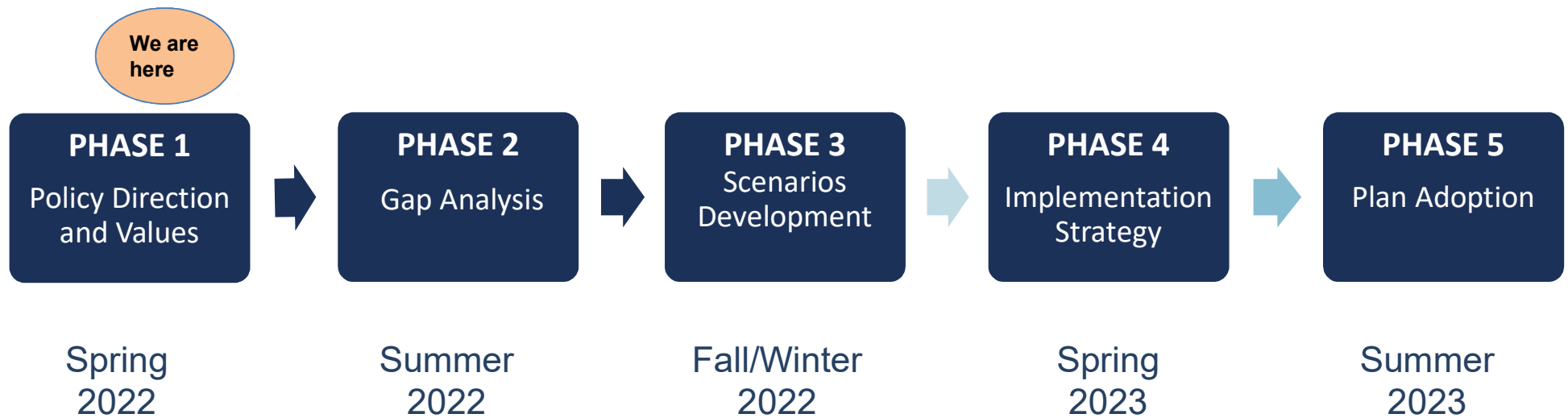
Support advancing environmental justice within the garbage and recycling system

Project Timeline



Phase 1 Policy Direction and Values

Spring 2022

Develop a shared understanding of existing policy guidance and commitment to values and outcomes that will guide the development of the plan.

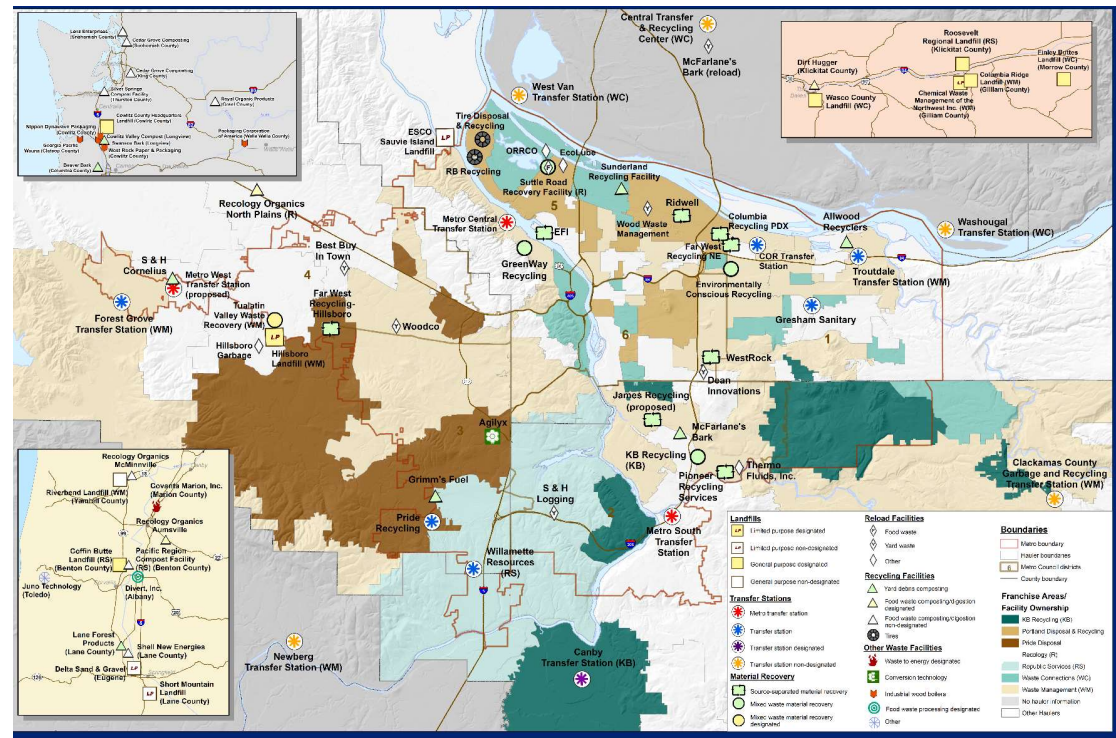
Milestone: Metro Council endorses values and outcomes that will guide plan development.



Phase 2 Gap Analysis Summer 2022

Identify current and future gaps in the garbage and recycling system of public, private and non-profit facilities.

Milestone: Metro Council reviews and provides feedback on the system gaps analysis.



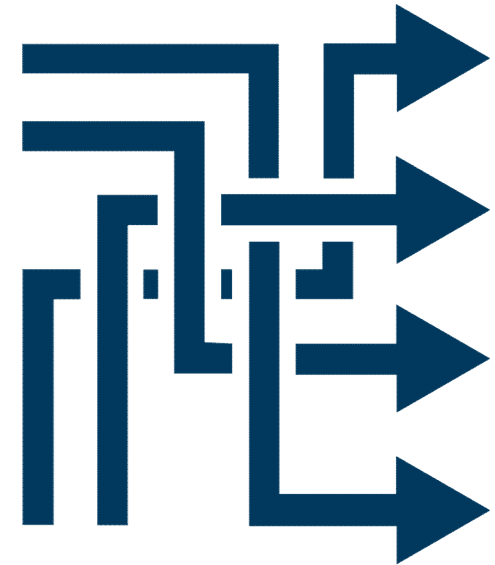
Regional Solid Waste Facilities

Phase 3 Scenarios Development

Fall/Winter 2022

Develop alternative future scenarios to consider tradeoffs of different paths forward and select a preferred scenario.

Milestone: Metro Council endorses scenario for plan implementation.



Phase 4 Implementation Strategy

Spring 2023

Prioritize facility investments, identify funding mechanisms, and develop tools for future plan implementation.

Milestone: Metro Council endorses facility priorities and financing options for plan implementation



Phase 5 Plan Adoption

June 2023 – July 2023

Engage stakeholders in review of the plan and bring to Metro Council for adoption.

Milestone: Metro Council considers adoption of the Garbage and Recycling System Facilities Plan.

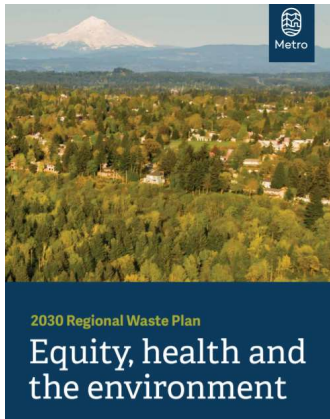
