

Metro garbage and recycling system overview



Reference document for Regional Waste Advisory Committee

This document includes information and links to resources which collectively provide an overview of Metro’s regulatory requirements for the garbage and recycling generated within the region and the facilities that accept and manage the material.

Metro oversees the region’s garbage and recycling system, a responsibility that includes ensuring that all of the waste generated in the region is managed in a manner that protects public health and safety and safeguards the environment.

The region’s garbage and recycling system includes a variety of different facilities that receive and process waste such as transfer stations, material recovery facilities, compost facilities, landfills, etc. Metro requires that the region’s waste be transported to an appropriate destination, and Metro staff inspect facilities to monitor for compliance and provide technical assistance.

Metro sets operating, record keeping, and reporting requirements for the facilities that receive the garbage and recycling generated within the region. Metro collects data from these facilities to monitor the flow of waste, inform system planning efforts, and ensure that the regional system fee and excise tax is paid as required.

Metro area waste leaving the region must be transported to a facility or disposal site that is either designated as part of the region’s garbage and recycling system or under the authority of a Metro issued non-system license.
