



How does it work? | ¿Como funciona?

- Since 1986, Metro has provided CEG as a way to support and invest in communities that host solid waste facilities.
- \$1 is generated for every ton of putrescible waste that comes through a facility
- Dry or construction waste along with yard debris is exempt





How is a grant program initiated?

¿Cómo se inicia un programa de subvenciones?

1. Host city > Metro > nonprofit organization (IGA or contract)
2. Organization administering grants establishes a grant committee
3. Grant committees can be comprised of elected officials and/or community members
4. Grant committees make decisions on the enhancement boundaries and awards
5. Funds generated must be awarded within 3 years



Eligibility | Elegibilidad



1. Located in **or benefit those** in target area
2. Nonprofits, local governments may apply
3. May not replace other readily available funds
4. May not promote or inhibit religion.
5. Must not discriminate based on race, ethnicity, age, gender, or sexual orientation.
6. If project on private land, must document landowner permission.



Community Enhancement Grant Program Goals

Metas del programa CEG

- a. Improve the appearance or environmental quality of the community.
- b. Reduce the amount or toxicity of waste.
- c. Increase reuse and recycling opportunities.
- d. Result in rehabilitation or upgrade of real or personal property owned or operated by a nonprofit organization having 501(c)(3) status under the Internal Revenue Code.

CEG Goals Cont. | Metas continuado...

- e. Result in the preservation or enhancement of wildlife, riparian zones, wetlands, forest lands and marine areas, and/or improve the public awareness and the opportunities to enjoy them.
- f. Result in improvement to, or an increase in, recreational areas and programs.
- g. Result in improvement in safety.
- h. Benefit youth, seniors, low income persons or underserved populations.





- Areas with capacity for future residential and employment growth










