Subject: Construction innovation should be a factor

I have brought this up while we were able to personally come to meetings. Perhaps I should elaborate.

I know most public discussion of pubic investments gets down to planning decisions and also existing or hoped-for policy. I will suggest there is an important third element that should influence decision-making: and that is construction technology.

All cities around the world have to deal with more or less the same issues. The ones that don't have as much money to spend, strive to be innovative, and this produces cost effective solutions that other cities should note.

Oregon has sometimes uses innovative technology to financial benefit. One example I often use is that of the Alsea Bay Bridge on US Hwy 101, which has proven to be cost effective in both initial construction and in maintenance.

Oregon is a wood products leader. Engineered and/or treated lumber is making a favorable comeback as a cost effective material. Perhaps we should use wood for lighter duty pedestrian crossings. Certainly prefabricated metal would be cost effective. Concrete construction is costly when it must be built over a roadway or waterway.

I have read of an example where state engineers redesigned interchanges and intersections and saved quite a lot of money. It may be that some of the projects in the final selection for Measure 2020 could be rethoult for cost savings. The public might even be able to contribute solutions.
