1:40 p.m.	Regional Mobility Policy Update <i>What measures will replace or at least augment the current volume-to-capacity ratio (v/c ratio) mobility measure? V/C measures vehicle volumes relative to road capacity during PM peak hours but does not measure mobility for people riding a bus or train, biking, walking or moving goods, and does not fully reflect the impacts of Transportation System Management & Operations (TSMO) and Transportation Demand Management (TDM) solutions. Last year Metro and the Oregon Department of Transportation jointly started policy work that will update the way the region defines mobility and measures success. The project team will ask for TransPort's input on proposed measures and ideas on how to operationalize them with existing data, new data sources and agreements among agencies. Contribute your thoughts on measures that will help to mainstream TSMO well into the future.
