> What measures will replace or at least augment the current volumeto-capacity ratio (v/c ratio) mobility measure? V/C measures vehicle volumes relative to road capacity during PM peak hours but does not measure mobility for people riding a bus or train, biking, walking or moving goods, and does not fully reflect the impacts of Transportation System Management & Operations (TSMO) and Transportation
