This past Spring, Computer Science seniors and graduate students used Google Cloud Platform, Python, Postgresql, Kafka, Pandas, Beautiful Soup, MapBox, JSON and related technologies to build data pipelines to handle ~15GB of TriMet bus data (GPS breadcrumb data and CAD/AVL stop data).
