Garbage and Recycling System Facilities Plan Outcomes (Draft for Review 4/8/22)

As an accompanying document to the 2030 Regional Waste Plan, the Garbage and Recycling System Facilities Plan (GRSFP) will be guided by the Regional Waste Plan values and racial equity principles. Together, these six values and three equity principles constitute the values framework for the GRSFP, and this document defines the desired plan outcomes.

The project team drafted the outcomes below based on input received from Metro's Regional Facility Planning Steering Team, as well as a review of the relevant Regional Waste Plan goals and actions. Many of the outcomes relate to existing goals and actions in the 2030 Regional Waste Plan, but are further specified below to align with this project's focus on defining the future infrastructure investments needed to fill the gaps in the regional garbage and recycling system. Each outcome is noted as to whether it is expected to be achieved during the GRSFP's planning process (the next 1.5 years) and/or the implementation phase (as facilities are built over the next 20 years).

Before being considered for Metro Council's endorsement in late May 2022, the GRSFP outcomes will be shared and discussed by the Regional Waste Advisory Committee (RWAC), Metro's Committee on Racial Equity (CORE), the Metro Policy Advisory Committee (MPAC) and, if possible, by the project's Community Advisory Group (if convened by mid-May 2022).
